## **LETTER OF DIRECTION**

Dear Ms. Mackinnon:

Re: Hydro One Networks Inc. (Hydro One)

Application for Leave to Construct -Richview by Trafalgar Reconductoring

The OEB has now issued its Notice of Hearing for Hydro One's application for the Richview by Trafalgar Reconductoring Project (Notice). The English and French versions of the Notice will be published by the OEB, in accordance with directions to the OEB's media agent which were copied to you. Please note that you must comply with the directions in paragraphs 1 through 3 below **prior to August 26, 2021**, which is the publication date of the newspaper in which the Notice will appear last. If you are unable to comply with the directions within this timeframe, you must inform the Registrar immediately at registrar@oeb.ca.

## You are directed:

- To conduct a search of title forthwith, sufficient to determine the current registered property owners and encumbrancers with lands or interest in the lands directly affected by the proposed reconductoring of the transmission line and related work.
- 2. No later than the date the English and French versions of the Notice are posted on Hydro One's website in accordance with paragraph 3, to arrange for the service of the enclosed Notice, in the exact form accompanying this letter and the application and the evidence, directly on each of the following:
  - a. All property owners and encumbrancers with lands or interest in lands identified in the search of title referred to in paragraph 1

- All generators connected directly to the Hydro One transmission line to which the proposed transmission line and related facilities will connect
- All transmission customers of Hydro One connected directly to the transmission line to which the proposed transmission line and related facilities will connect
- d. All owners and operators of rail lines, telecommunications (e.g., telephone) or other utilities along or crossing the route and location for the proposed transmission line and related facilities will connect
- e. The Clerk of the City of Toronto
- f. The Clerk of the City of Mississauga
- g. CreateTO
- h. Toronto Hydro-Electric System Limited
- i. Alectra Utilities Corporation
- j. Oakville Hydro Electricity Distribution Inc.
- k. All indigenous communities that have been consulted or with lands or interest in the lands directly affected by the proposed upgrade and construction of the transmission line and related facilities
- I. The following government ministries and agencies:
  - i. Ministry of Energy
  - ii. Ministry of Infrastructure
  - iii. Ministry of Environment, Conservation and Parks
  - iv. Ministry of Northern Development, Mines, Natural Resources and Forestry
  - v. Ministry of Indigenous Affairs
  - vi. Ministry of Transportation
  - vii. Ministry of Municipal Affairs and Housing
  - viii. Ministry of Heritage, Tourism, Culture and Sport
  - ix. Ministry of the Attorney General

- 3. To post a copy of the Notice, the application and the evidence, and any amendments thereto, on Hydro One's website.
- 4. To file with the OEB an affidavit in both electronic and paper forms proving completion of the matters in paragraphs 1 through 3 above, immediately thereafter with the relevant Notices and original post office registration receipts (where applicable), or courier confirmation lists attached as appendices.
- 5. To provide a copy of the Notice, the application and the evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any documents or materials when serving the Notice other than documents or materials expressly required by this letter of direction to be served.
