6. CKSPFN intends to participate in any available pre-hearing procedures, including interrogatories or technical conferences, and settlement conferences. CKSPFN also intends to participate in any oral hearings of this matter, and in written or oral submissions, as well as any other parts of the process that the Board should order.

# **Nature of Hearing Requested**

7. Until all outstanding interrogatories have been answered, CKSPFN believes it is premature to assess whether a written or an oral hearing is more appropriate in this proceeding.
