Re: EB-2020-0150 - NextBridge 2022-2031 Custom IR Application - SEC Cost Claim

We are counsel to the School Energy Coalition ("SEC"). Enclosed, please find SEC's cost claim in this matter on the Board's form with accompanying detailed dockets.

This was a complex proceeding, as it was the first time the Board has adjudicated the issue of a Custom IR framework for a single line asset utility. There was a multi-day settlement conference and a 3-day oral hearing. Counsel for SEC took a leading role in this proceeding, acting as a coordinator among the intervenors during the settlement process, and took a lead in the cross-examination during the oral hearing.

SEC submits that its participation in this proceeding was thorough and valuable, and was designed to maximize its assistance to the Board. SEC therefore requests reimbursement of its reasonably incurred costs as set forth in the attached cost claim.

For the purposes of the Board's cost claim form, we have used the 'Other Conference – Preparation' category for time docketed for items that do not fall within the other categories (i.e., Procedural matters, discussions amongst parties to develop the Issues List, reviewing the Board's decisions, and reviewing and filing submissions on the Draft Rate Order).
