Re: EB-2021-0032 Hydro One Networks Inc. – 2018-2022 Distribution Rate Application – 2022 Annual Rate Update

The Ontario Energy Board (OEB) received Hydro One Networks Inc.'s 2022 Custom IR Annual Update application on August 20, 2021.

The OEB has commenced processing the application and has assigned it file number EB-2021-0032. An employee of the OEB, to whom authority has been delegated under Section 6 of the *Ontario Energy Board Act, 1998,* intends to make a decision on the application without holding a hearing.

Your application is available on the OEB's <u>2022 Electricity Distribution Rates</u> webpage. You are directed to make a copy of the application available in a prominent place on your company's website within 3 business days.

OEB staff will be in contact with you directly throughout the course of the proceeding, and may have questions regarding the application that will require your prompt attention. In the event that there are matters that need to be discussed orally, OEB staff has set aside **October 6, 2021** for a virtual meeting with you. Please ensure that you have appropriate staff available for that date (or promptly inform your OEB case manager if it is unworkable). Please note that you are responsible for ensuring that all of the documents filed with the OEB, including responses to OEB staff questions and any other supporting evidence, **do not include "personal information"** as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*, unless filed in accordance with rule 9A of the OEB's *Rules of Practice and Procedure*.

OEB staff will also outline any additional information that you need to provide, and may pose written questions that will be provided to you no later than **October 11, 2021**. If any additional information is received from you in response to OEB staff questions, OEB staff requests that Hydro One update applicable models as necessary.

OEB staff requests that you provide any updated models, along with any additional information requested by OEB staff, by no later than **October 25, 2021**. All changes to the models should be documented.

Following these steps, the OEB will provide you with a draft decision and, where possible, a draft rate order and applicable models. You will be given a period of seven days within which to provide comments on the draft decision (and, in some circumstances, you may need to file a separate draft rate order). The OEB will consider your comments (if any), prior to issuing a final decision and rate order.

Please quote file number, **EB-2021-0032** for all materials filed and submit them in searchable/unrestricted PDF format with a digital signature through the <u>OEB's online</u> <u>filing portal</u>.

- Filings should clearly state the sender's name, postal address, telephone number and e-mail address
- Please use the document naming conventions and document submission standards outlined in the <u>Regulatory Electronic Submission System (RESS)</u> <u>Document Guidelines</u> found at the <u>Filing Systems page</u> on the OEB's website
- Parties are encouraged to use RESS. Those who have not yet <u>set up an</u> <u>account</u>, or require assistance using the online filing portal can contact <u>registrar@oeb.ca</u> for assistance

Please note that the timely processing of the application depends on the receipt of information within the specified timelines.
