Further to the Ontario Energy Board's (OEB) acknowledgement letter dated August 31, 2021, the OEB has completed its preliminary review of your 2022 Transmission Revenue Requirement application and will now commence the processing of your application. An employee of the OEB, to whom authority has been delegated under Section 6 of the *Ontario Energy Board Act, 1998*, intends to make a decision on the application without holding a hearing.

Your application is available on the OEB's [Electricity Transmission Rates webpage](#) of the OEB's website. You are directed to make a copy of the application available in a prominent place on your company's website within three business days.

OEB staff may have questions regarding the application and will be in contact with you directly throughout the course of the application review. OEB staff may contact you by email and/or by telephone. OEB staff has scheduled a teleconference for October 13, 2021, in the event that there are matters that need to be discussed further. Please ensure that appropriate members of your staff are available at that time or inform the OEB case manager below if this date is unworkable.

Please note that you are responsible for ensuring that all documents filed with the OEB, including responses to OEB staff questions and any other supporting evidence, **do not**

include “personal information” as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*, unless filed in accordance with rule 9A of the OEB’s *Rules of Practice and Procedure*.

As part of the 2022 application, you will update Hydro One’s revenue cap index and 2022 revenue requirement using the OEB’s inflation factor for incentive rate setting for 2022 rates. We anticipate that the OEB will issue that factor during the course of this proceeding.

Following these steps, the delegated decision maker will provide you with a draft of their proposed decision. You may comment on the draft decision within seven days. The delegated decision maker will consider your comments and issue a final decision.
