**EB-2021-0033 - Hydro One Networks Inc. – 2022 Distribution Rate Application for the Areas Formerly Served by Norfolk Power Distribution Inc., Haldimand County Hydro Inc., and Woodstock Hydro Services Inc.**

**EB-2021-0050 - Hydro One Networks Inc. – 2022 Distribution Rate Application for the Areas Formerly Served by Orillia Power Distribution Corp. and Peterborough Distribution Inc.**

In the OEB's letters of direction for the above-noted annual rate updates, Hydro One has been directed to serve notice on intervenors from the following proceedings:

- The MAADs applications for each of Norfolk Power Distribution Inc. (Norfolk) (EB-2013-0187), Woodstock Hydro Services Inc. (Woodstock) (EB-2014-0213), Haldimand County Hydro Inc. (Haldimand) (EB-2014-0244) on the one hand, and Peterborough Distribution Inc. (Peterborough) (EB-2018-0242) and Orillia Power Distribution Corporation (Orillia) (EB-2018-0270) on the other;
- Hydro One Distribution's last rate application (EB-2017-0049);
- Hydro One's upcoming Transmission and Distribution rate application (EB-2021-0110).

Appendix A includes a list of all intervenors from these proceedings. This will require service on 44 intervenors for EB-2021-0033 (Norfolk, Woodstock, Haldimand) and 45 intervenors for EB-2021-0050 (Peterborough and Orillia).

For the reasons set out below, Hydro One requests that Notice requirements be amended to include intervenors in the MAADs applications. In the alternative, Hydro One requests that Notice requirements be amended to include intervenors in the MAADs applications and the last cost of service applications for each of Norfolk, Woodstock, Haldimand, Peterborough and Orillia. To do otherwise would require service on an overly broad group of intervenors and could cause confusion and frustration for some of the proposed intervenors. Furthermore, Hydro One's proposal would ensure regulatory efficiency.

**Service on Intervenors from Hydro One's Last Rate Application (EB-2017-0049)**

Hydro One requests that the OEB revisit the need to use the list of intervenors from EB-2017-0049 for service of Notice of the annual rate updates for Norfolk, Woodstock, Haldimand, Peterborough and Orillia.

Intervenors in EB-2017-0049 should be excluded. Many of them made submissions specific to stand-alone issues unrelated to the rates for Norfolk, Woodstock, Haldimand, Peterborough and Orillia. For example, telecom companies and cottage associations who made submissions on the pole attachment rate and the seasonal rate class, respectively. Some of these intervenors have no interest in the forthcoming annual rate updates and serving notice may lead to confusion or frustration.

The customers of Norfolk, Woodstock, Haldimand, Peterborough and Orillia were not impacted by the rates derived in EB-2017-0049.

**Service on Intervenors in Hydro One's Upcoming Joint Rate Application for Transmission and Distribution (EB-2021-0010)**

Hydro One does not yet have a final list of intervenors in the above noted proceeding. Notwithstanding that, intervenors to the Joint Rate Application for Transmission and Distribution should be excluded from the Notice provisions in EB-2021-0033 and EB-2021-0050, particularly those intervening on stand-alone issues unrelated to the rates for Norfolk, Woodstock, Haldimand, Peterborough and Orillia (i.e. seasonal rates or Transmission).

Rates for Peterborough and Orillia are frozen for 2023-2027 period and customers of those utilities will not be impacted by the rates derived in EB-2021-0110.

By participating in the respective MAADs proceedings, intervenors indicated their interest in the rates of Norfolk, Woodstock, Haldimand, Peterborough and Orillia specifically. Service on these intervenors is appropriate and sufficient to allow meaningful participation in this proceeding.

Hydro One requests that the OEB reconsider the list of intervenors for service of Notice of the proceedings in EB-2021-0033 and EB-2021-0050.
