Re: Enbridge Gas Inc. - 2020 Federal Carbon Pricing Program Application Board File No.: EB-2019-0247, Costs for Chiefs of Ontario

Please find attached the cost claim of Chiefs of Ontario (COO) in the above-referenced proceeding (the Proceeding), filed pursuant to the Board's Decision and Order dated September 23, 2021 (the Decision).

COO respectfully requests an award of 100% of its eligible costs, given its strategic and principled participation in the Proceeding, reflecting the unique interests of First Nations across Ontario. COO submits that this request is supported by the following considerations:

1. COO participated effectively, taking a coordinated approach to the issues and coordinating with other intervenors to avoid overlap and maximize efficiency in all aspects of the Proceeding;
2. COO participated responsibly and made reasonable efforts to ensure that its participation was not unduly repetitive and was focused on relevant and material issues;
3. COO did not engage in conduct that unnecessarily lengthened the process; and
4. COO contributed to the Board's better understanding of issues in the Proceeding by filing written submissions.

We trust that this approach maximizes efficient use of resources and the right of otherwise unrepresented First Nations to be heard in a manner that is consistent with the Board's mandate and statutory objectives.

COO respectfully requests a full award of eligible costs.
