



## SIX NATIONS NATURAL GAS LIMITED

### Application for Certificates of Public Convenience and Necessity for and Municipal Franchise Agreements with the County of Brant and Norfolk County

#### PROCEDURAL ORDER NO. 1 October 13, 2021

SIX NATIONS NATURAL GAS LIMITED (SNNG) filed an application with the Ontario Energy Board (OEB) on August 30, 2021 under section 8 and 9 of the *Municipal Franchises Act*. The application is for an order approving SNNG's certificate of public convenience and necessity for and municipal franchise agreements with the County of Brant and Norfolk County to allow SNNG to serve Off-Reserve customers.

A Notice of Hearing was issued on September 17, 2021. Enbridge Gas Inc. (Enbridge Gas) applied for intervenor status. No objection was received from SNNG.

Enbridge Gas is approved as an intervenor. The list of parties in this proceeding is attached as Schedule A to this Procedural Order.

The OEB finds it is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

#### IT IS THEREFORE ORDERED THAT:

1. OEB staff and Enbridge Gas shall request any relevant information and documentation from SNNG that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on all parties, by **October 22, 2021**.
2. SNNG shall file with the OEB complete written responses to all interrogatories and serve them on all parties by **November 5, 2021**.
3. OEB staff and Enbridge Gas may file any written submission with the OEB and serve it on all parties by **November 19, 2021**.

4. SNNG may file a written reply submission with the OEB and serve it on all parties by **December 3, 2021**.

Parties are responsible for ensuring that any documents they file with the OEB, such as applicant and intervenor evidence, interrogatories and responses to interrogatories or any other type of document, **do not include personal information** (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's [Rules of Practice and Procedure](#).
