# Written Submission of the Ministry of Northern Development, Mines, Natural Resources and Forestry

### Introduction:

Enbridge Gas Limited ("Enbridge") made application ("the Application") to the Ministry of Northern Development, Mines, Natural Resources and Forestry ("NDMNRF") pursuant to the *Oil, Gas and Salt Resources Act* ("OGSRA") for two well drilling licences, one in each of the Corunna (proposed well TC 8) and the Ladysmith (proposed well TL8) Designated Gas Storage Areas.

On July 19, 2021, MNRF referred the Applications to the Ontario Energy Board ("OEB") pursuant to s. 40 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15 ("OEB Act") for a Report to the Minister.

The OEB initiated this proceeding subsequent to the NDMNRF referral.

On September 10, 2021, the OEB granted Intervenor status to each of the NDMNRF and Claire and Helen Robbins (the Robbins).

Further to Interrogatories and responses to Interrogatories, the NDMNRF is hereby providing its Written Submission.

### Analysis:

NDMNRF Petroleum Operations Section has reviewed Enbridge's Application, other Intervenor's filings, OEB Staff's Interrogatories (including the proposed conditions of approval) and Enbridge's Response to Interrogatories. We are satisfied that the Application is complete and that Enbridge has offered a complete response to all Interrogatories.

Based on the Application and this further information provided, NDNMRF has no objection to the Application's approval subject to the OEB Staff's proposed conditions of approval. With regard to those draft conditions of approval, we interpret that outstanding items that will or may be required from the Ministry of Hertiage, Sport, Tourism and Cultural Industries, Hydro One Networks Inc., St. Clair Township or the St. Clair Region Conservation Authority are in each instance addressed under OEB Staff draft conditions of approval #4 and/or #5.

We understand that Enbridge, as per its response to an Interrogatory from OEB Staff, accepts responsibility for all safety and environmental issues and will comply with the OGSRA, O.Reg. 245/97 made under the OGSRA, the Provincial Operating Standards and CSA Z341.1-14 "Storage of Hydrocarbons in Underground Formations" to the satisfaction of the NDMNRF.

#### **Conclusion and Relief Requested:**

NDMNRF has no objection to approval of the Application, subject to the OEB Staff's proposed conditions of approval.
