Please find attached the cost claim of the Chippewas of Kettle and Stony Point First Nation ("CKSPFN"), as represented by Southwind Corporate Development Inc., a wholly-owned subsidiary of CKSPFN ("Southwind"), in the above-referenced proceeding, filed pursuant to the OEB's Decision and Order dated October 7, 2021.

Southwind respectfully requests an award of 100% of its eligible costs. This request is supported by the following considerations:

- (a) Southwind participated in this proceeding to represent the interests of CKSPFN and its Treaty and Aboriginal rights;
- (b) Southwind was amenable to the general approach proposed for the regulatory account and participated responsibly by ensuring that its submissions were focused on relevant and material issues such as HONI's cost allocation methodology;
- (c) Southwind's concerns were reasonable and were shared by another intervenor;
- (d) Southwind's submissions prompted HONI to offer greater clarity and transparency on its cost allocation methodology, assisting the OEB in determining the scope of the proposed ATP Account; and

- (e) Southwind's participation was justified given the impact of the request on several projects, including future projects, as well on potential partnerships.

In summary, Southwind is of the view that its participation has helped clarify the scope of costs to be included in the ATP Account and the appropriate avenues to discuss station assets and costs for both CKSPFN and other prospective First Nation partners.

Southwind respectfully requests a full award of eligible costs.

Dr. Richardson has over 30 years of experience as a skilled facilitator supporting project implementation, impact assessments and building agreements between energy, infrastructure and resource management project proponents, community/non-governmental organizations, government agencies, and rural/Indigenous communities. He fosters constructive engagement to create shared value between communities and infrastructure proponents.

Dr. Richardson has appeared as a witness several times in various regulatory proceedings and has presented before the Ontario Energy Board on a number of occasions. As a consultant to Anwaatin Inc., he is an experienced intervenor before the Board, representing the interest of Indigenous communities. Dr. Richardson has a high level of familiarity with the Ontario Energy Board's practice directions, rules of practice and procedure, filing requirements and related administrative guidance.

On behalf of Anwaatin Inc., and other parties Dr. Richardson has been active in representing various Indigenous interests before the Ontario Energy Board in a number of electricity and natural gas proceedings and consultations. Dr. Richardson has assisted Anwaatin and its First Nation clients in being a pioneer of distributed energy resource (DERs) initiatives before the Board and helped to achieve the first landed grid energy storage projects to improve poor electricity reliability in vulnerable Indigenous communities (see EB-2017-0355, Decision and Order, August 23, 2018 and EB-2017-0049, Decision and Order, March 7, 2019).

Dr. Richardson was recently appointed as the represent of Anwaatin in the Ontario Energy Board's Framework for Energy Innovation: Distributed Resources and Utility Incentives consultation (Board File No.: EB-2021-0118). He is or was an active participant in, among others, the following Board proceedings: EB-2021-0002; EB-2021-0004; EB-2020-0194; EB-2020-0212; and EB-2020-0106. Dr. Richardson was also recently appointed to the Ontario Energy Board's Adjudicative Modernization Committee which considers best practices and approaches to adjudication that enhance the OEB's efficiency and effectiveness in delivering on its mandate to regulate Ontario's energy sector as required under provincial legislation.

Dr. Richardson has experience with several large scale and small scale energy infrastructure development projects, and energy regulatory and policy matters, working on behalf of First Nation governments across Ontario. He has extensive experience navigating the deployment, use, and integration of DERs as well alleviating energy poverty in and around Indigenous communities. He is also a recipient of the Canadian Urban Institute's Brownie Award recognizing outstanding achievement in building and maintaining effective working partnerships with professionals, the local community and others involved in Brownfields redevelopment, and a Consulting Engineers of Ontario, Canada Award for Indigenous Traditional Knowledge achievements.
