EPCOR Natural Gas Limited Partnership

Application for natural gas distribution rates beginning January 1, 2022

PROCEDURAL ORDER NO. 1 October 22, 2021

EPCOR Natural Gas Limited Partnership (EPCOR) filed an incentive rate-setting mechanism application with the Ontario Energy Board (OEB) on September 14, 2021 under section 36 of the *Ontario Energy Board Act*, 1998, S.O. 1998, c. 15, (Schedule B) seeking approval for changes to the rates that EPCOR charges for natural gas distribution in its Aylmer service area, beginning January 1, 2022.

The OEB issued a Notice of Hearing on September 30, 2021. No persons applied for intervenor status.

It is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

IT IS THEREFORE ORDERED THAT:

- 1. OEB staff shall request any relevant information and documentation from EPCOR that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on EPCOR, by **October 29, 2021**.
- 2. EPCOR shall file with the OEB complete written responses to all interrogatories by, **November 10, 2021**.
- 3. Any written submissions by OEB staff shall be filed with the OEB and served on EPCOR by **November 17, 2021**.
- 4. Any reply submissions by EPCOR, shall be filed with the OEB by **November 24**, **2021**.

Parties are responsible for ensuring that any documents they file with the OEB, such as applicant and intervenor evidence, interrogatories and responses to interrogatories or any other type of document, **do not include personal information** (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's Rules of Practice and Procedure.
