2. Nominee's Technical or Policy Experience With Natural Gas or Electricity IRP (utility system planning, experience with IRP solutions, cost-benefit analysis and comparison of IRP/facility solutions, etc.)

In my over 30 years in the natural gas industry, I have worked for, led and consulted for multiple natural gas utilities in Ontario and one in Nova Scotia. My technical experience includes system facilities planning and design. I have led regulatory involvement for both utilities and ratepayers for over 20 years contributing to a balanced approach between utility prudency and ratepayer value.

In my over 12 years as a consultant, I have developed diversified approaches to gas acquisition and load balancing which incorporate risk management as part of the cost-benefit analysis. As part of that experience, I have developed RFP's and contracted for market-based IRP solutions providing firm, economical solutions while avoiding facility-based contracting costs. On behalf of clients and the public interest, I have advocated for market-based solutions to avoid facilities in multiple proceedings including our presentation of feasible market-based approaches in the recent IRP proceeding.

After 7 years of facility planning, design and construction with Union Gas, I worked for 13 years for Kitchener Utilities initially as the engineer then the last 10 years as the director. As director, I had overall responsibility for gas supply procurement, system design and regulatory involvement. I have also served on the board of the Ontario Natural Gas Association and the Ontario Energy Association and as a member of the Advisory Council to the TSSA and of the TCPL Tolls Task Force.

In addition to OEB involvement on behalf of the utility, I have represented ratepayers, utilities and industry associations. I initially submitted evidence and testified on benefits of market-based solutions at the OEB about 20 years ago. I have consistently advocated for an economically, sound, risk-informed approach to the design of systems and contracting to meet customers' peak and seasonal needs.
