**Re: Amhil Enterprises
Application for Electricity Wholesaler License
OEB File Number EB-2021-0220**

The Ontario Energy Board (OEB) received Amhil Enterprises's application for a electricity wholesaler license on October 7, 2021. The OEB has assigned file number EB-2021-0220 to the application. The application will be decided by an employee of the OEB who has been delegated this authority pursuant to section 6 of the Ontario Energy Board Act, 1998 (Delegated Authority). The Delegated Authority intends to make a decision on the application without holding a hearing.

The OEB has preliminary reviewed Amhil Enterprises'(Amhil) application for an electricity wholesale license. In order to further proceed with the application review, some additional information is required. Please submit the following:

1. In response to the requirements outlined in section 10 – Finance, Amhil submitted a letter from the applicant's bank and Certificate of Liability Insurance. This optional information is generally allowed for the new companies that have not yet produced their financial statements at the time of filing the application. Considering that Amhil has been in business since December 1996, the

requirement to provide audited or unaudited financial statements for the last two years has to be met.

Please file Amhil's financial statements for the last two years. Unaudited financial statement must be signed by the key individual.

2. Is Amhil currently a customer of a local distribution company? If no, please describe how electricity is being supplied to Amhil, e.g., under a retail contract, directly from the IESO, or from a generator.
3. Please describe qualifications of Amhil's personnel who will be responsible for electricity wholesaling activities. If Amhil intends to hire a contractor to conduct electricity wholesaling activities, please identify the contractor and describe their relevant qualifications and experience.

The OEB will resume processing your application once the above information has been filed. If the above information is not filed within 30 days of the date of this letter, the OEB may close the file for this application.

Once your application is complete, the Delegated Authority expects to issue a final decision on your application within 60-90 days. In the event the Delegated Authority decides to deny or otherwise modify the relief you requested in your application, you will be given an opportunity to provide comments. The Delegated Authority will consider your final comments, if any, prior to issuing a decision and order.
