

EPCOR Natural Gas Limited Partnership

**Application for natural gas distribution rates beginning
January 1, 2022**

**PROCEDURAL ORDER NO. 1
November 3, 2021**

EPCOR Natural Gas Limited Partnership (EPCOR) filed an incentive rate-setting mechanism application with the Ontario Energy Board (OEB) on September 27, 2021 under section 36 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B) seeking approval for changes to the rates that EPCOR charges for natural gas distribution in its South Bruce service area, beginning January 1, 2022.

The OEB issued a Notice of Hearing on October 12, 2021. No persons applied for intervenor status.

It is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

IT IS THEREFORE ORDERED THAT:

1. OEB staff shall request any relevant information and documentation from EPCOR that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on EPCOR, by **November 8, 2021**.
2. EPCOR shall file with the OEB complete written responses to the interrogatories by, **November 15, 2021**.
3. Any written submissions by OEB staff shall be filed with the OEB and served on EPCOR by **November 22, 2021**.
4. Any reply submissions by EPCOR, shall be filed with the OEB by **November 29, 2021**.

Parties are responsible for ensuring that any documents they file with the OEB, such as applicant and intervenor evidence, interrogatories and responses to interrogatories or any other type of document, **do not include personal information** (as that phrase is

defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's [Rules of Practice and Procedure](#).
