Sioux Lookout Hydro Inc.

Application for electricity distribution rates beginning May 1, 2022

PROCEDURAL ORDER NO.

November 15, 2021, Revised November 17, 2021

Sioux Lookout Hydro Inc. (Sioux Lookout Hydro) filed an incentive rate-setting mechanism (IRM) application with the Ontario Energy Board (OEB) on October 5, 2021 under section 78 of the *Ontario Energy Board Act*, *1998*, S.O. 1998, c. 15, (Schedule B) seeking approval for changes to the rates that Sioux Lookout Hydro charges for electricity distribution, beginning May 1, 2022.

The OEB issued a Notice of Hearing on October 22, 2021. No persons applied for intervenor status.

It is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

IT IS THEREFORE ORDERED THAT:

- 1. OEB staff shall request any relevant information and documentation from Sioux Lookout Hydro that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on Sioux Lookout Hydro, by **November 29, 2021**.
- 2. Sioux Lookout Hydro shall file with the OEB complete written responses to the interrogatories by, **December 13, 2021**.
- 3. Any written submissions by OEB staff shall be filed with the OEB and served on Sioux Lookout Hydro by **January 12, 2022**.
- 4. Any reply submissions by Sioux Lookout Hydro, shall be filed with the OEB by January 26, 2022.

Parties are responsible for ensuring that any documents they file with the OEB, such as applicant and intervenor evidence, interrogatories and responses to interrogatories or any other type of document, **do not include personal information** (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's <u>Rules of Practice and Procedure</u>.
