**Application for a new certificate of public convenience and necessity for the
Municipality of Brockton, the Municipality of West Grey, and the Township of
Chatsworth**

PROCEDURAL ORDER NO. 1

November 29, 2021

EPCOR Natural Gas Limited Partnership (ENGLP) filed an application with the Ontario Energy Board (OEB) on October 20, 2021 under sections 8 and 9 of the *Municipal Franchises Act*. The application is for an order approving ENGLP's certificates of public convenience and necessity and municipal franchise agreements with the Municipality of Brockton, the Municipality of West Grey, and the Township of Chatsworth to allow ENGLP to bring natural gas service to unserved areas within each of the municipalities and township.

A Notice of Hearing was issued on November 4, 2021. Each of Enbridge Gas Inc. (Enbridge Gas), JAKO Developments Inc., and the Municipality of Brockton applied for intervenor status. No objection was received from ENGLP.

Enbridge Gas, JAKO Developments Inc., and the Municipality of Brockton are approved as intervenors. The list of parties in this proceeding is attached as Schedule A to this Procedural Order.

The OEB finds it is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

IT IS THEREFORE ORDERED THAT:

1. OEB staff and intervenors shall request any relevant information and documentation from ENGLP that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on all parties, by **December 6, 2021**.
2. ENGLP shall file with the OEB complete written responses to all interrogatories and serve them on all parties by **December 13, 2021**.
3. OEB staff and intervenors may file any written submission with the OEB and serve it on all parties by **January 12, 2022**.
4. ENGLP may file a written reply submission with the OEB and serve it on all parties by **January 19, 2022**.

Parties are responsible for ensuring that any documents they file with the OEB, such as applicant and intervenor evidence, interrogatories and responses to interrogatories or any other type of document, **do not include personal information** (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's [Rules of Practice and Procedure](#).
