1 OVERVIEW

The Ontario Energy Board is approving changes to the rates that Alectra Utilities Corporation (Alectra Utilities) charges to distribute electricity to its customers, effective January 1, 2022. This Decision impacts each of the following former Alectra Utilities rate zones: Enersource Hydro Mississauga Inc. (Enersource RZ), PowerStream Inc. (PowerStream RZ), Hydro One Brampton Networks Inc. (Brampton RZ), Horizon Utilities Corporation (Horizon RZ) and Guelph Hydro Electricity System Inc. (Guelph RZ).

As a result of this Decision, effective January 1, 2022, the monthly bill impact for a residential customer consuming 750 kWh will be as follows:

- For the Enersource RZ, there will be a monthly total bill increase of \$2.08.
- For the Brampton RZ, there will be a monthly total bill increase of \$2.40.
- For the PowerStream RZ, there will be a monthly total bill increase of \$1.82.
- For the Horizon RZ, there will be a monthly total bill increase of \$1.72.
- For the Guelph RZ, there will be a monthly total bill increase of \$1.86.

The bill impacts shown do not factor in applicable taxes or the Ontario Electricity Rebate.

2 CONTEXT AND PROCESS

Alectra Utilities filed its application on August 18, 2021 under section 78 of the *Ontario Energy Board Act, 1998* (OEB Act) and in accordance with Chapter 3 of the OEB's [Filing Requirements for Incentive Rate-Setting Applications](#) (Filing Requirements). The application was based on the Price Cap Incentive Rate-setting (Price Cap IR) option.

The Price Cap IR option is one of three incentive rate-setting mechanisms (IRM) approved by the OEB.¹ It involves the setting of rates through a cost of service application in the first year and mechanistic price cap adjustments which may be approved through IRM applications in each of the ensuing adjustment years.

Following the merger in 2017 that formed Alectra Utilities, the distributor was granted a ten-year deferred rebasing period from 2017 to 2026 for the Horizon RZ, Enersource RZ, PowerStream RZ and Brampton RZ. The Guelph RZ was acquired by Alectra Utilities subsequent to the merger, and for this rate zone, the distributor was granted a ten-year deferred period from 2019 to 2028. The Price Cap IR option is applicable to each of Alectra Utilities' rate zones throughout the deferred rebasing period.

The OEB follows a standardized and streamlined process for hearing IRM applications filed under Price Cap IR. In each adjustment year of a Price Cap IR term, the OEB prepares a Rate Generator Model that includes, as a placeholder, information from the distributor's past proceedings and annual reporting requirements. A distributor will then review, complete, and include the model with its application, and may update the model during the proceeding to make any necessary corrections or to incorporate new rate-setting parameters as they become available.

Alectra Utilities serves approximately 1,062,000 mostly residential and commercial electricity customers in its five rate zones. These five rate zones cover 17 communities that include: the cities of Hamilton and St. Catharines in the Horizon RZ; the City of Brampton in the Brampton RZ; the cities of Barrie, Markham and Vaughan and the towns of Aurora, Richmond Hill, Alliston, Beeton, Bradford West Gwillimbury, Penetanguishene, Thornton, and Tottenham in the PowerStream RZ; the City of Mississauga in the Enersource RZ; and the City of Guelph and the Village of Rockwood in the Guelph RZ.

The application was supported by pre-filed written evidence and completed Rate Generator Models and as required during the proceeding, Alectra Utilities updated and clarified the evidence.

3 DECISION OUTLINE

Each of the following issues is addressed in this Decision, together with the OEB's findings.

- Annual Adjustment Mechanism
- Retail Transmission Service Rates
- Group 1 Deferral and Variance Accounts
- Lost Revenue Adjustment Mechanism Variance Account Balance
- Renewable Generation Connection Rate Protection
- Capitalization Deferral Accounts

Instructions for implementing Alectra Utilities' new rates and charges are set out in the final section of this Decision.

This Decision does not address rates and charges approved by the OEB in prior proceedings, such as specific service charges² and loss factors, which are out of scope of an IRM proceeding and for which no further approvals are required to continue to include them on the distributor's Tariff of Rates and Charges.

4 ANNUAL ADJUSTMENT MECHANISM

Alectra Utilities has applied to change its rates, effective January 1, 2022, based on a mechanistic rate adjustment using the OEB-approved **inflation minus X-factor** formula applicable to IRM applications. The adjustment applies to distribution rates (fixed and variable) uniformly across all customer classes.³

The components of the Price Cap IR adjustment formula applicable to Alectra Utilities are set out in the table below. Inserting these components into the formula results in a 1.90% increase to Alectra Utilities' rates: **3.00% = 3.30% - (0.00% + 0.30%)**.

An inflation factor of 3.30% applies to all IRM applications for the 2022 rate year.

On August 6, 2021, the OEB issued a Notice on its own motion to initiate a proceeding to consider the inflation factor to be used to set rates for electricity transmitters and electricity and natural gas distributors for the year 2022. The OEB issued its Decision and Order on November 18, 2021, establishing the 2022 inflation factor.

The X-factor is the sum of the productivity factor and the stretch factor. It is a productivity offset that varies among different groupings of distributors. Subtracting the X-factor from inflation ensures that rates decline in real, constant-dollar terms, providing distributors with a tangible incentive to improve efficiency or else experience declining net income. The productivity component of the X-factor is based on industry conditions over a historical study period and applies to all IRM applications for the 2022 rate year.

The stretch factor component of the X-factor is distributor specific. The OEB has established five stretch factor groupings, each within a range from 0.00% to 0.60%. The stretch factor assigned to any particular distributor is based on the distributor's total cost performance as benchmarked against other distributors in Ontario. The stretch factor assigned to Alectra Utilities is 0.30%, resulting in a rate adjustment of 3.00%.

Findings

Alectra Utilities' request for a 3.00% rate adjustment is in accordance with the annually updated parameters set by the OEB. The adjustment is approved, and Alectra Utilities' new rates shall be effective January 1, 2022.

5 RETAIL TRANSMISSION SERVICE RATES

Each of Alectra Utilities' rate zones is partially embedded within Hydro One Networks Inc.'s distribution system.

To recover its cost of transmission services, Alectra Utilities requests approval to adjust the retail transmission service rates (RTSRs) that it charges its customers in accordance with the Uniform Transmission Rates (UTRs) and host distributor RTSRs currently in effect.

Findings

Alectra Utilities' proposed adjustment to its RTSRs is approved. The RTSRs were adjusted based on the current OEB-approved UTRs and host-RTSRs.⁷

UTRs and host-RTSRs are typically approved annually by the OEB. In the event that new UTRs or host-RTSRs take effect during Alectra Utilities' 2022 rate year, any resulting differences (from the prior-approved UTRs and host-RTSRs) are to be captured in Retail Settlement Variance Accounts 1584 (Retail Transmission Network Charge) and 1586 (Retail Transmission Connection Charge).

6 GROUP 1 DEFERRAL AND VARIANCE ACCOUNTS

In each year of an IRM term, the OEB will review a distributor's Group 1 deferral and variance accounts in order to determine whether those balances should be disposed. OEB policy states that Group 1 account balances should be disposed if they exceed, on a net basis (as a debit or credit), a pre-set disposition threshold of \$0.001 per kWh, unless a distributor justifies why balances should not be disposed.⁸ If the net balance does not exceed the threshold, a distributor may still request disposition.

Horizon RZ

The 2020 year-end net balance for the Horizon RZ's Group 1 accounts eligible for disposition, including interest projected to December 31, 2021, is a credit of \$6,866,320, and pertains to variances accumulated during the 2020 calendar year. This amount represents a total credit claim of \$0.0013 per kWh, which exceeds the disposition threshold. Alectra Utilities has requested disposition of this amount over a one-year period.

Included in the Group 1 accounts are certain variances related to costs that are paid for by a distributor's customers on different bases, depending on their classification. Namely, "Class A" customers, who participate in the Industrial Conservation Initiative, pay for Global Adjustment (GA) charges based on their contribution to the five highest Ontario demand peaks over a 12-month period. "Class B" customers pay for GA charges based on their monthly consumption totals, either as a standalone charge or embedded in the Regulated Price Plan (RPP).⁹ A similar mechanism applies to Class A and Class B customers for Capacity Based Recovery (CBR) charges.¹⁰ The balance in the GA variance account is attributable to non-RPP Class B customers and is disposed through a separate rate rider. The balance in the CBR Class B variance account is attributable to all Class B customers.

Alectra Utilities had Class A customers in the Horizon RZ during the period in which variances accumulated, however, the CBR Class B rate riders calculated rounded to zero at the fourth decimal place in one or more of the rate classes. In this event, the balance of the CBR Class B variance account is disposed along with Account 1580 – Wholesale Market Service Charge through the general Deferral and Variance Account rate rider.

During the period in which variances accumulated, the Horizon RZ had customers transition between Class A and Class B. Under the general principle of cost causality, customer groups that cause variances which are recorded in Group 1 accounts should be responsible for paying (or receiving credits) for their disposal. Alectra Utilities has proposed to allocate a portion of the Horizon RZ's GA balance to its transition customers, based on their customer-specific consumption levels.¹¹ The amounts allocated to each transition customer are proposed to be refunded, by way of 12 equal monthly installments.

In 2019, Alectra Utilities identified an omission related to the Horizon RZ in reporting embedded generation energy kWhs to the IESO, requiring a total adjustment of \$8.1 million. The OEB approved this adjustment as part the 2021 rate application. However, the OEB did not approve the allocation of this adjustment between RPP and non-RPP customers and directed Alectra Utilities to confer with OEB staff following the conclusion of the proceeding. The OEB approved the 2019 balances in Account 1588 and Account 1589 on an interim basis. Alectra Utilities confirmed that it conferred with OEB staff and both were in agreement on the revised allocation of the \$8.1 million and the corresponding updates to the continuity schedules in the current proceeding.

Findings

The balances proposed for disposition reconcile with the amounts reported as part of the OEB's *Electricity Reporting and Record-Keeping Requirements*.

The OEB approves the disposition of a credit balance of \$6,866,320 as of December 31, 2020, including interest projected to December 31, 2021, for the Horizon RZ's Group 1 accounts on a final basis. The OEB also approves on a final basis the Horizon RZ's December 31, 2019 balances in Account 1588 and Account 1589 that were previously disposed on an interim basis in Alectra Utilities' 2021 rates proceeding.¹²

Table 6.1 identifies the principal and interest amounts, which the OEB approves for disposition.

The balance of each of the Group 1 accounts approved for disposition shall be transferred to the applicable principal and interest carrying charge sub-accounts of Account 1595. Such transfer shall be pursuant to the requirements specified in the *Accounting Procedures Handbook for Electricity Distributors*.¹³ The date of the transfer must be the same as the effective date for the associated rates, which is generally the start of the rate year.

The OEB approves these balances to be disposed through final rate riders and payments, as calculated in the Rate Generator Model. The final rate riders, charges, and payments, as applicable, will be in effect over a one-year period from January 1, 2022 to December 31, 2022.¹⁴

Brampton RZ

The 2020 year-end net balance for the Brampton RZ's Group 1 accounts eligible for disposition, including interest projected to December 31, 2021, is a credit of \$3,313,332, and pertains to variances accumulated during the 2020 calendar year. This amount represents a total credit claim of \$0.0008 per kWh, which does not exceed the disposition threshold. Alectra Utilities has requested disposition of this amount over a one-year period.

Alectra Utilities had Class A customers in the Brampton RZ during the period in which variances accumulated, however, the CBR Class B rate riders calculated rounded to zero at the fourth decimal place in one or more of the rate classes. In this event, the balance of the CBR Class B variance account is disposed along with Account 1580 – Wholesale Market Service Charge through the general Deferral and Variance Account rate rider.

During the period in which variances accumulated, the Brampton RZ had customers transition between Class A and Class B. Alectra Utilities has proposed to allocate a portion of the Brampton RZ's GA balance to its transition customers, based on their customer-specific consumption levels.¹⁵ The amounts allocated to each transition customer are proposed to be recovered, by way of 12 equal monthly installments.

Findings

The balances proposed for disposition reconcile with the amounts reported as part of the OEB's *Electricity Reporting and Record-Keeping Requirements*.

The OEB approves the disposition of a credit balance of \$3,313,332 as of December 31, 2020, including interest projected to December 31, 2021, for the Brampton RZ's Group 1 accounts on a final basis.

Table 6.2 identifies the principal and interest amounts, which the OEB approves for disposition.

The balance of each of the Group 1 accounts approved for disposition shall be transferred to the applicable principal and interest carrying charge sub-accounts of Account 1595. Such transfer shall be pursuant to the requirements specified in the *Accounting Procedures Handbook for Electricity Distributors*.¹⁶ The date of the transfer must be the same as the effective date for the associated rates, which is generally the start of the rate year.

The OEB approves these balances to be disposed through final rate riders and charges, as calculated in the Rate Generator Model. The final rate riders, charges, and payments, as applicable, will be in effect over a one-year period from January 1, 2022 to December 31, 2022.¹⁷

PowerStream RZ

The 2020 year-end net balance for the PowerStream RZ's Group 1 accounts eligible for disposition, including interest projected to December 31, 2021, is a debit of \$3,225,393, and pertains to variances accumulated during the 2020 calendar year. This amount represents a total debit claim of \$0.0004 per kWh, which does not exceed the disposition threshold. Alectra Utilities has requested disposition of this amount over a one-year period.

Alectra Utilities had Class A customers in the PowerStream RZ during the period in which variances accumulated so it has applied to have the balance of the CBR Class B variance account disposed through a separate rate rider for Class B customers to ensure proper allocation between Class A and Class B customers.

During the period in which variances accumulated, the PowerStream RZ had customers transition between Class A and Class B. Alectra Utilities has proposed to allocate a portion of the PowerStream RZ's GA and CBR Class B balances to its transition customers, based on their customer-specific consumption levels.¹⁸ The amounts allocated to each transition customer are proposed to be recovered (or refunded, as applicable), by way of 12 equal monthly installments.

Findings

The balances proposed for disposition reconcile with the amounts reported as part of the OEB's *Electricity Reporting and Record-Keeping Requirements*.

The OEB approves the disposition of a debit balance of \$3,225,393 as of December 31, 2020, including interest projected to December 31, 2021, for the PowerStream RZ's Group 1 accounts on a final basis.

Table 6.3 identifies the principal and interest amounts, which the OEB approves for disposition.

The balance of each of the Group 1 accounts approved for disposition shall be transferred to the applicable principal and interest carrying charge sub-accounts of Account 1595. Such transfer shall be pursuant to the requirements specified in the *Accounting Procedures Handbook for Electricity Distributors*.¹⁹ The date of the transfer must be the same as the effective date for the associated rates, which is generally the start of the rate year.

The OEB approves these balances to be disposed through final rate riders, charges and payments, as calculated in the Rate Generator Model. The final rate riders, charges,

and payments, as applicable, will be in effect over a one-year period from January 1, 2022 to December 31, 2022.²⁰

Enersource RZ

The 2020 year-end net balance for the Enersource RZ's Group 1 accounts eligible for disposition, including interest projected to December 31, 2021, is a debit of \$6,474,589, and pertains to variances accumulated during the 2020 calendar year. This amount represents a total debit claim of \$0.0009 per kWh, which does not exceed the disposition threshold. Alectra Utilities has requested disposition of this amount over a one-year period.

Alectra Utilities had Class A customers in the Enersource RZ during the period in which variances accumulated, however, the CBR Class B rate riders calculated rounded to zero at the fourth decimal place in one or more of the rate classes. In this event, the balance of the CBR Class B variance account is disposed along with Account 1580 – Wholesale Market Service Charge through the general Deferral and Variance Account rate rider.

During the period in which variances accumulated, the Enersource RZ had customers transition between Class A and Class B. Alectra Utilities has proposed to allocate a portion of the Enersource RZ's GA balance to its transition customers, based on their customer-specific consumption levels.²¹ The amounts allocated to each transition customer are proposed to be recovered, by way of 12 equal monthly installments.

Findings

The balances proposed for disposition reconcile with the amounts reported as part of the OEB's *Electricity Reporting and Record-Keeping Requirements*.

The OEB approves the disposition of a debit balance of \$6,474,589 as of December 31, 2020, including interest projected to December 31, 2021, for the Enersource RZ's Group 1 accounts on a final basis.

Table 6.4 identifies the principal and interest amounts, which the OEB approves for disposition.

The balance of each of the Group 1 accounts approved for disposition shall be transferred to the applicable principal and interest carrying charge sub-accounts of Account 1595. Such transfer shall be pursuant to the requirements specified in the *Accounting Procedures Handbook for Electricity Distributors*.²² The date of the transfer must be the same as the effective date for the associated rates, which is generally the start of the rate year.

The OEB approves these balances to be disposed through final rate riders and charges, as calculated in the Rate Generator Model. The final rate riders, charges, and payments, as applicable, will be in effect over a one-year period from January 1, 2022 to December 31, 2022.²³

Guelph RZ

The 2020 year-end net balance for the Guelph RZ's Group 1 accounts eligible for disposition, including interest projected to December 31, 2021, is a debit of \$8,014, and pertains to variances accumulated during the 2020 calendar year. This amount represents a total debit claim of less than \$0.0001 per kWh, which does not exceed the disposition threshold. Alectra Utilities has requested disposition of this amount over a one-year period.

Alectra Utilities had Class A customers in the Guelph RZ during the period in which variances accumulated, however, the CBR Class B rate riders calculated rounded to zero at the fourth decimal place in one or more of the rate classes. In this event, the balance of the CBR Class B variance account is disposed along with Account 1580 – Wholesale Market Service Charge through the general Deferral and Variance Account rate rider.

During the period in which variances accumulated, the Guelph RZ had customers transition between Class A and Class B. Alectra Utilities has proposed to allocate a portion of the Guelph RZ's GA balance to its transition customers, based on their customer-specific consumption levels.²⁴ The amounts allocated to each transition customer are proposed to be refunded, by way of 12 equal monthly installments.

Findings

The balances proposed for disposition reconcile with the amounts reported as part of the OEB's *Electricity Reporting and Record-Keeping Requirements*.

The OEB approves the disposition of a debit balance of \$8,014 as of December 31, 2020, including interest projected to December 31, 2021 for the Guelph RZ's Group 1 accounts on a final basis.

Table 6.5 identifies the principal and interest amounts, which the OEB approves for disposition.

The balance of each of the Group 1 accounts approved for disposition shall be transferred to the applicable principal and interest carrying charge sub-accounts of Account 1595. Such transfer shall be pursuant to the requirements specified in the *Accounting Procedures Handbook for Electricity Distributors*.²⁵ The date of the transfer must be the same as the effective date for the associated rates, which is generally the start of the rate year.

The OEB approves these balances to be disposed through final rate riders and payments, as calculated in the Rate Generator Model. The final rate riders, charges,

7 LOST REVENUE ADJUSTMENT MECHANISM VARIANCE ACCOUNT

The OEB utilizes a Lost Revenue Adjustment Mechanism Variance Account (LRAMVA), which captures a distributor's revenue implications resulting from differences between actual and forecast conservation savings included in its last OEB-approved load forecast.²⁷

Distributors delivered conservation and demand management (CDM) programs to their customers through the Conservation First Framework (CFF) that began on January 1, 2015 until March 20, 2019, when the CFF was revoked.²⁸ The OEB provided direction to distributors seeking to claim program savings up to December 31, 2021 related to CFF programs or other conservation programs they delivered.²⁹

Alectra Utilities has applied to dispose of its LRAMVA debit balance of \$9,584,402. The balance consists of lost revenues in 2019 from CDM programs and carrying charges. The actual conservation savings claimed by Alectra Utilities under the CFF were validated with reports from the IESO, project level savings files, or both.

Actual conservation savings for each rate zone were compared against Alectra Utilities' forecasted conservation savings included in its last OEB-approved load forecast for each rate zone.

Alectra Utilities applied to dispose of a total LRAMVA debit balance of \$9,584,402, based on incremental CDM program activity in 2019 for all five rate zones, inclusive of projected interest to December 31, 2021. A summary of the balance by rate zone is provided in Table 7.1 below.

Alectra Utilities engaged IndEco Strategic Consulting Inc. (IndEco) to review and verify the process and related calculations used for determining 2019 CDM savings, including the allocation of savings across rate zones and rate classes. Alectra Utilities stated that IndEco confirmed the accuracy of the amounts included in the LRAMVA workforms, and that the process of allocation of the CDM savings was appropriate.

Alectra Utilities proposes to dispose of the LRAMVA balances over a 12-month period, with the details by rate zone as follows:

- Brampton RZ – The LRAMVA balance is \$1,485,506, including forecasted carrying charges of \$42,564. Alectra Utilities is seeking recovery of lost revenues for the period January 1, 2019 to December 31, 2019 resulting from the following: (i) 2013 to 2018 CDM persistence savings in 2019; and (ii) incremental savings from IESO-funded CDM programs implemented in 2019. Actual savings were compared to an LRAMVA threshold approved in the former Brampton Hydro's 2015 cost of service proceeding.³⁰
- Enersource RZ - The LRAMVA balance is \$3,126,536, including forecasted carrying charges of \$89,584 through to December 31, 2021. Alectra Utilities is seeking recovery of lost revenues for the period January 1, 2019 to December 31, 2019 resulting from the following: (i) 2011 to 2018 CDM persistence savings in 2019; and (ii) incremental savings from IESO-funded CDM programs implemented in 2019. Actual savings were compared to an LRAMVA threshold approved in the former Enersource Hydro Mississauga Inc.'s 2013 cost of service proceeding.³¹
- Horizon RZ - The LRAMVA balance is \$690,183, including forecasted carrying charges of \$19,776 through to December 31, 2021. Alectra Utilities is seeking recovery of lost revenues for the period January 1, 2019 to December 31, 2019 resulting from the following: (i) 2014 to 2018 CDM persistence savings in 2019; and (ii) incremental savings from IESO-funded CDM programs implemented in 2019. Actual savings were compared to an LRAMVA threshold approved in the former Horizon Utilities' 2015 Custom IR proceeding.³²
- Guelph RZ - The LRAMVA balance is \$654,383, including forecasted carrying charges of \$18,750 through to December 31, 2021. Alectra Utilities is seeking recovery of lost revenues for the period January 1, 2019 to December 31, 2019 resulting from the following: (i) 2014 to 2018 CDM persistence savings in 2019;

and (ii) incremental savings from IESO-funded CDM programs implemented in 2019. Actual savings were compared to an LRAMVA threshold established in the former Guelph Hydro Electric System Inc.'s 2016 cost of service proceeding.³³

- PowerStream RZ – The LRAMVA balance is \$3,627,794 including forecasted carrying charges of \$103,946 through to December 31, 2021. Alectra Utilities is seeking recovery of lost revenues for the period January 1, 2019 to December 31, 2019 resulting from the following: (i) 2015 to 2018 CDM persistence savings in 2019; and (ii) incremental savings from IESO-funded CDM programs implemented in 2019. Actual savings were compared to an LRAMVA threshold established in the former PowerStream Inc.'s 2017 cost of service proceeding.³⁴

Findings

The OEB finds that Alectra Utilities' LRAMVA balances have been calculated in accordance with the OEB's CDM-related guidelines and updated LRAMVA policy. The OEB approves the disposition of Alectra Utilities' LRAMVA debit balance of \$9,584,402, as set out in Table 7.2 below.

8 RENEWABLE GENERATION CONNECTION RATE PROTECTION

Subsection 79.1 (1) of the OEB Act states that the OEB may provide Renewable Generation Connection Rate Protection (RGCRP) compensation amounts to eligible distributors. Ontario Regulation 330/09 (Cost Recovery Re Section 79.1 of the Act), made under the OEB Act prescribes the methodology the OEB uses to determine the amount to be collected for any given year.

Ontario distributors are required to plan their systems based on their expectations of new electricity generation projects connecting to their systems. Based on their plans, distributors can apply to the OEB for funding to recover the cost of assets to enable and to connect generators to their distribution systems, including generators using renewable sources of energy such as wind or solar. The OEB is permitted to take steps to ensure that all Ontario customers, not just the ratepayers of the individual distributor, contribute to the costs of investments to connect renewable generators in accordance with applicable legislation.

The OEB approved 2021 RGCRP funding for the Brampton RZ, PowerStream RZ, and Enersource RZ in Alectra Utilities' 2021 rate proceeding.³⁵ The OEB's 2021 rates decision noted that OEB staff and Alectra Utilities agreed on updated RGCRP models for the three rate zones to extend the calculations for the RGCRP funding amounts for each year between 2022 to 2026. In the current application, Alectra Utilities has requested 2022 RGCRP funding for its Brampton RZ, PowerStream RZ, and Enersource RZ based on these calculations.

Brampton RZ

In its application, Alectra Utilities noted that the OEB approved the RGCRP amounts related to the renewable enabling improvement investments and renewable expansion investments from 2015 to 2019 for the Brampton RZ in the 2015 cost of service application of the former Hydro One Brampton Networks Inc.³⁶ Alectra Utilities has requested to collect RGCRP funding associated with these investments of \$136,430 in 2022 (or \$11,369 per month) from all provincial ratepayers, as detailed in the RGCRP model filed for the Brampton RZ.

Findings

The OEB approves the eligibility of the Brampton RZ plans and the associated RGCRP funding of \$136,430 in 2022 or \$11,369 per month from all provincial ratepayers.

PowerStream RZ

In its application, Alectra Utilities noted that the OEB approved the RGCRP amounts related to the renewable enabling improvement investments and renewable expansion investments from 2016 to 2020 for the PowerStream RZ in the 2016 Custom IR application of the former PowerStream Inc.³⁷ Alectra Utilities has requested to collect RGCRP funding associated with these investments of \$248,681 in 2022 (or \$20,723 per month) from all provincial ratepayers, as detailed in the RGCRP model filed for the PowerStream RZ.

Findings

The OEB approves the eligibility of the PowerStream RZ plans and the associated RGCRP funding of \$248,681 in 2022 or \$20,723 per month from all provincial ratepayers.

Enersource RZ

In its application, Alectra Utilities noted that the OEB approved the former Enersource Hydro Mississauga Inc.'s basic Green Energy Plan (GEA Plan) in its 2013 cost of service proceeding.³⁸ Alectra Utilities also noted that the GEA Plan identified the projects and expenditures associated with the connection of renewable generation to its system and discussed constraints on the ability to connect renewable generation. Alectra Utilities has requested to collect RGCRP funding associated with these investments of \$147,377 in 2022 (or \$12,281 per month) from all provincial ratepayers for the Enersource RZ, as detailed in the RGCRP model filed for the Enersource RZ.

Alectra Utilities noted that the 2022 funding request for the Enersource RZ is inclusive of true-up amounts for 2020 and 2021. Alectra Utilities further noted that this true-up approach is consistent with the calculation of RGCRP amounts in previous proceedings for the Enersource RZ. Alectra Utilities confirmed that it has applied the same approach in determining the RGCRP amount for the Enersource RZ that had been applied and approved in the 2021 proceeding.

Findings

The OEB approves the eligibility of the Enersource RZ plans and the associated RGCRP funding of \$147,377 in 2022 or \$12,281 per month from all provincial ratepayers.

9 CAPITALIZATION DEFERRAL ACCOUNTS

In the OEB's Partial Decision and Order for Alectra Utilities' 2020 IRM application (2020 Partial Decision), the OEB adopted what it referred to as the Account 1576 approach to calculating the amounts to be recorded in the deferral accounts established to capture the impacts of changes in capitalization policy following the amalgamation of Alectra Utilities.³⁹ The OEB also determined that disposition of the accounts would take place when Alectra Utilities next rebases.

In the same application, Alectra Utilities had noted that it had migrated to a new ERP system and therefore could no longer track the actual impacts of the change in accounting policy for each RZ starting in 2019. To record amounts going forward, Alectra Utilities proposed an allocation methodology to determine the capitalization policy impacts for each RZ starting with the 2019 fiscal year. The OEB, in the 2020 Partial Decision, accepted Alectra Utilities' approach, but also concluded "... that it is appropriate to continue to monitor the results of the allocation methodology for unexpected results that might lead to the conclusion that an amendment is required to the allocation approach on a prospective basis."⁴⁰

In the OEB's Decision and Order for Alectra Utilities' 2021 IRM application, the OEB directed Alectra Utilities to file evidence in its 2022 IRM application applying the accepted methodology, quantifying the differences between actual to forecast allocations and explaining key drivers, particularly if the differences are material.⁴¹

In this application, Alectra Utilities has provided the balances as at December 31, 2020 in the capitalization deferral accounts for the Horizon RZ, Enersource RZ, Brampton RZ and Guelph RZ. For the 2020 balances, Alectra Utilities used the same allocation methodology that had been used to determine the 2019 balances, which was the same allocation methodology that had been accepted by the OEB in the 2020 Partial Decision. Alectra Utilities applied a set of calculated allocation percentages to the 2020 actual distribution plant capital to determine the impacts to the Horizon RZ, Enersource RZ, Brampton RZ, and Guelph RZ. Alectra Utilities explained that it determined the allocation percentages by rate zone based on a ratio of the actual impact of the capitalization policy change, prior to the ERP convergence, to actual distribution plant capital for the corresponding period. Alectra Utilities also explained that any changes relative to the capitalization policy impacts included in the 2020 rate proceeding are driven by the actual distribution plant capital expenditures in any given year.

Alectra Utilities explained that differences between the originally forecasted impacts and those reported in this proceeding are the result of lower than forecasted distribution plant expenditures for the Enersource RZ and Brampton RZ, and higher than forecasted distribution plant expenditures for the Horizon RZ.⁴²

Alectra Utilities further stated that an amendment to the allocation methodology is not required for a number of reasons including:

- Reliance on actual impacts calculated by rate zone for 2017 and 2018 when legacy ERP systems were available
- Allocation percentages were based on a ratio of the actual impact of the change in 2017 and 2018 by rate zone to actual rate zone-specific distribution plant capital for the corresponding period
- Methodology is easy to understand, validate, and uses readily available rate zone specific data (i.e. distribution plant capital by rate zone)⁴³

Findings

The OEB accepts the allocation methodology applied by Alectra Utilities to the capitalized deferral accounts for the Horizon RZ, Enersource RZ, Brampton RZ and Guelph RZ as at December 31, 2020. This allocation methodology was also accepted by the OEB in its 2020 Partial Decision.

This issue of allocation will persist in Alectra Utilities' IRM proceedings until it rebases in 2028. In 2028, it is expected that Alectra Utilities will apply to the OEB to dispose of the accumulated balances in the capitalization deferral accounts and parties will have the opportunity to review and test the accumulated balances at that time. In the interim, annual allocations are expected. As indicated in the 2020 Partial Decision, the allocation of the capitalized differential balance among rate zones is not an exact science and estimates are required. A number of factors will change the annual allocation calculations, resulting in differences between forecast and actual impacts.

In its 2023 IRM application, Alectra Utilities should continue to file evidence justifying why the allocation methodology remains appropriate, quantifying the differences between actual to forecast allocations and explaining the key drivers, particularly if the differences are material.

10 IMPLEMENTATION

This Decision is accompanied by Rate Generator Models, applicable supporting models, and a Tariff of Rates and Charges (Schedule A). The Rate Generator Models also incorporate the rates set out in Table 10.1.

Each of these rates is a component of the “Regulatory Charge” on a customer’s bill, established annually by the OEB through a separate, generic order. The RRRP, WMS and CBR rates were set by the OEB on December 10, 2020.⁴⁴

The Smart Metering Entity Charge is a component of the “Distribution Charge” on a customer’s bill, established by the OEB through a separate order. The Smart Metering Entity Charge was set by the OEB on March 1, 2018.⁴⁵

In the *Report of the Board: Review of Electricity Distribution Cost Allocation Policy*,⁴⁶ the OEB indicated that it will review the default province-wide microFIT charge annually to ensure it continues to reflect actual costs in accordance with the established methodology. Distributors shall apply the updated value, if applicable, following the OEB’s announcement of the microFIT charge for the 2022 rate year.

Where service is provided to combined residential and business, or residential and agricultural, whether seasonal or all-year premises, and the wiring does not provide for separate metering, the service shall normally be classed as general service. APPLICATION

No rates and charges for the distribution of electricity and charges to meet the costs of any work or service done or furnished for the purpose of the distribution of electricity shall be made except as permitted by this schedule, unless required by the Distributor's Licence or a Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, or as specified herein.
