



EPCOR Natural Gas Limited Partnership

Application for natural gas distribution rates beginning January 1, 2022

PROCEDURAL ORDER NO. 3 December 3, 2021

EPCOR Natural Gas Limited Partnership (EPCOR) filed an incentive rate-setting mechanism application with the Ontario Energy Board (OEB) on September 27, 2021 under section 36 of the *Ontario Energy Board Act*, 1998, S.O. 1998, c. 15, (Schedule B) seeking approval for changes to the rates that EPCOR charges for natural gas distribution in its South Bruce service area, beginning January 1, 2022.

Procedural Order No. 1 was issued on November 3, 2021 which provided for interrogatories, submissions and a reply submission. OEB staff filed a submission on November 19, 2021. EPCOR filed a partial reply submission on November 29, 2021.

In a letter dated November 29, 2021, EPCOR requested an extension to the date for the filing of its reply submission on the Municipal Tax Variance Account (MTVA) from November 29, 2021 to December 1, 2021. In Procedural Order No. 2, issued November 30, 2021, the OEB granted EPCOR's request for extension to file a complete reply submission by December 1, 2021.

On December 1, 2021, EPCOR submitted its complete reply submission, including the MTVA issue. In its reply submission, EPCOR anticipated that OEB staff may require time to review the reply submission and may wish to respond. In order to ensure the implementation of 2022 rates by January 1, 2022, EPCOR proposed that a Decision and Order could be made in respect of all other issues in this IRM application and that the outstanding MTVA issue be addressed as a second phase of this proceeding (Phase 2).

The OEB is granting this request and will bifurcate the application into two phases: Phase 1- all the issues excluding the MTVA issue and Phase 2- the MTVA issue.

It is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

IT IS THEREFORE ORDERED THAT:

- 1. A submission on the MTVA issue by OEB staff shall be filed with the OEB by **December 10, 2021**.
- 2. A reply submission by EPCOR on the MTVA issue shall be filed with the OEB by **December 17, 2021**.

Parties are responsible for ensuring that any documents they file with the OEB, such as applicant and intervenor evidence, interrogatories and responses to interrogatories or any other type of document, **do not include personal information** (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's Rules of Practice and Procedure.
