The redactions relate to the details of the Company's contract for Gas Transportation and Sale with Gazifere Inc. which are commercially sensitive as their disclosure could disadvantage the customer. Additionally, the contract information is not necessary in order to address FRPO's request of comparing alternatives to the section of pipeline that needs to be replaced with NPS 16 pipe. On the balance the harm from the disclosure does not outweigh the little probative value of the of providing the contract demand for comparing alternatives.
