Re: EB-2021-0076- Small Utilities Filing Requirements Working Group - Cost Claim

We are counsel to the School Energy Coalition ("SEC"). Enclosed, please find SEC's cost claim in this matter on the Board's form with accompanying detailed dockets.

In the OEB's May 11th, 2021 letter, it noted that "[t]he maximum number of cost eligible hours per participant to prepare for, attend and report on working group meetings is 1.5 times the time spent by the participant's representative in each meeting." SEC has docketed 5.55hrs more than the maximum number of eligible hours based on the Board's formula. We ask that the Board exercise its discretion and grant this additional time.

The work undertaken by all members of the working group, including the undersigned, included more than simply preparing, attending, and reporting on working group meetings. There was a requirement for extensive review and line-by-line edits of the proposed new filing requirements, and significant discussion amongst members through email, including after the final meeting, that may have not been contemplated by the Board at the start of the process. SEC submits that these tasks were integral to the success of the working group, the revised filing requirement, and as recognition in the OEB's most recent letter, the expectation that certain learnings from the process could be applied to all distributors.
