## **1. LRAMVA Claim**

OEB Staff supported SLHI's request to dispose of its December 31, 2020 LRAMVA.<sup>1</sup> OEB Staff requested SLHI to confirm whether the carrying charges of \$1,131 are projected to December 31, 2021 or April 30, 2022. SLHI confirms that the above carrying charges are to December 31, 2021. Carrying charges to April 30, 2022 amount to \$30.

## **2. Other Elements of the Application**

OEB Staff's submission supported all other aspects of SLHI's 2022 IRM Application, including the price-cap IR adjustment<sup>2</sup>, Retail Transmission Service Rates<sup>3</sup>, Shared Tax Adjustments<sup>4</sup>, Group 1 Deferral and Variance Accounts<sup>5</sup> and the Z-Factor – June 2021 Windstorm claim<sup>6</sup>.

SLHI has no concerns with OEB Staff submissions or comments on these matters.
