# Rideau St. Lawrence Distribution Inc.

# Application for electricity distribution rates and other charges beginning January 1, 2022

# PROCEDURAL ORDER NO. 1 January 28, 2022

Rideau St. Lawrence Distribution Inc. (Rideau St. Lawrence Distribution) filed a cost of service application with the Ontario Energy Board (OEB) on December 1, 2021, under section 78 of the *Ontario Energy Board Act*, *1998*, S.O. 1998, c. 15, (Schedule B), seeking approval for changes to the rates that Rideau St. Lawrence Distribution charges for electricity distribution, beginning January 1, 2022.

A Notice of Hearing was issued on December 17, 2021. Each of School Energy Coalition (SEC) and Vulnerable Energy Consumers Coalition (VECC) applied for intervenor status and cost eligibility.

No objection was received from Rideau St. Lawrence Distribution.

SEC and VECC are approved as intervenors and are eligible to apply for an award of costs under the OEB's <u>Practice Direction on Cost Awards</u>. The list of parties in this proceeding is attached as Schedule A to this Procedural Order.

Cost eligible intervenors should be aware that the OEB will not generally allow the recovery of costs for the attendance of more than one representative of any party unless a compelling reason is provided when cost claims are filed.

# **Issues List**

At this time, the OEB is making provision for the development of an issues list prior to the filing of interrogatories. Rideau St. Lawrence Distribution, OEB staff and the intervenors shall develop and OEB staff shall file a proposed issues list for the OEB's consideration. Parties are encouraged to reach consensus on the proposed issues list. The OEB will approve an issues list prior to the filing of interrogatories.

# Interrogatories

The OEB is also making provision for written interrogatories. The OEB will review the single test year application both in the context of the projects and programs that are

requested for the test year and from the perspective of the distributor's plans for the subsequent four years until the next scheduled rebasing application.

Parties should examine the value presented by the proposed investments as opposed to focusing only on the costs. Parties should also assess the fit between the applicant's plans and its stated objectives and consider how the plans contribute to positive outcomes for customers, in particular those outcomes that arise from the asset management decisions reflected in the applicant's distribution system plan. The OEB will consider the entire five-year distribution system plan to assess the planning and pacing proposals of the applicant and whether the test year requests are appropriately aligned with the distribution system plan. The OEB will also consider productivity and benchmarking results in assessing cost forecasts, bill impacts and distributor performance.

Parties should not engage in detailed exploration of items that do not appear to be material. Parties should use the materiality thresholds documented in Chapter 2 of the Filing Requirements as a guide. In making its decision on cost awards, the OEB will consider whether intervenors made reasonable efforts to ensure that their participation in the hearing was focused on material issues.

Parties should consult sections 26 and 27 of the OEB's <u>Rules of Practice and</u> <u>Procedure</u> regarding required naming and numbering conventions and other matters related to interrogatories.

# **Presentation of Settlement Proposal**

The OEB is making provision for a settlement conference. Following the settlement conference, provision is being made for the filing of letters informing the OEB of the status of the settlement discussions, the presentation of any settlement proposal filed by Rideau St. Lawrence Distribution, whether full or partial, and for the presentation of any unsettled issues to be adjudicated by the OEB. Rideau St. Lawrence Distribution's presentation is intended to summarize and provide any salient information for the OEB's consideration in reviewing the settlement proposal.

It is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

# IT IS THEREFORE ORDERED THAT:

1. OEB staff shall file a proposed issues list, or, alternatively, shall advise the OEB in writing that the parties and OEB staff have been unable to reach an agreement on a draft issues list by **February 10, 2022**.

- OEB staff shall request any relevant information and documentation from Rideau St. Lawrence Distribution that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on all parties by February 17, 2022.
- 3. Intervenors shall request any relevant information and documentation from Rideau St. Lawrence Distribution that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on all parties by **February 22, 2022**.
- 4. Rideau St. Lawrence Distribution shall file with the OEB complete written responses to all interrogatories and serve them on OEB staff and all intervenors by **March 10, 2022**.
- 5. A settlement conference among the parties and OEB staff will be convened on **March 28-29, 2022** starting at 9:30 a.m. If necessary, the settlement conference will continue on **March 30, 2022**. This will be a virtual event and information on how to participate will be provided in advance of the conference.
- 6. **Within 48 hours** of the conclusion of the settlement conference, Rideau St. Lawrence Distribution shall file a letter informing the OEB of the status of the settlement discussions including whether a tentative agreement had been reached or if the parties propose to continue the settlement discussions.
- If there is no settlement proposal arising from the settlement conference, Rideau St. Lawrence Distribution shall file a statement to that effect with the OEB by April 6, 2022. In that event, parties shall file and serve on the other parties by April 13, 2022 any submissions on which issues shall be heard in writing, and for which issues the OEB should hold an oral hearing.
- 8. If there is a settlement, any settlement proposal arising from the settlement conference shall be filed with the OEB on or before **April 25, 2022**. In addition to outlining the terms of any settlement, the settlement proposal should contain a list of any unsettled issues, indicating with reasons whether the parties believe those issues should be dealt with by way of oral or written hearing.
- 9. Any submission from OEB staff on a settlement proposal shall be filed with the OEB and served on all parties by **May 2, 2022**.
- 10. The OEB is setting a tentative date of **May 10, 2022, starting at 9:30 a.m.** for Rideau St. Lawrence Distribution to present to the OEB any settlement proposal

and a summary of any unsettled issues in the case. OEB staff will, at the direction of the OEB, confirm or amend this date in subsequent correspondence.

Parties are responsible for ensuring that any documents they file with the OEB, such as applicant and intervenor evidence, interrogatories and responses to interrogatories or any other type of document, **do not include personal information** (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's <u>Rules of Practice and Procedure</u>.
