1 OVERVIEW

The Ontario Energy Board is approving changes to the rates that Hydro One Networks Inc. (Hydro One) charges to distribute electricity to its customers, effective January 1, 2022 and implemented February 1, 2022.

The application relates to the rates requested by Hydro One for the legacy service areas of the former Norfolk Power Distribution Inc. (Norfolk Power), the former Haldimand County Hydro Inc. (Haldimand County Hydro) and the former Woodstock Hydro Services Inc. (Woodstock Hydro), collectively referred to as Acquired Utilities.

The OEB issued its Decision and Order (Decision) on the application on December 16, 2022. In the Decision, the OEB ordered Hydro One to file a draft rate order (DRO) reflecting the OEB's findings. On January 13, 2022, Hydro One filed a DRO, and on January 18, 2022, OEB staff filed its submission on the DRO. The OEB staff submission included an updated Tariff of Rates and Charges, as well as two minor comments related to the implementation date referred to in the DRO and certain information in the accompanying rate models.

In its reply submission on the DRO, Hydro One sought clarification on whether its request to discontinue the Woodstock Hydro Incremental Capital Module (ICM) rate rider had been approved. Continuing the ICM rate rider would result in additional revenues to be collected and higher overall bills for customers relative to Hydro One's proposal. If Hydro One's request to discontinue the ICM rate rider was confirmed to be approved, as stated in the Decision, Hydro One requested that two areas (Tab 19 – Final Tariff Schedule and Tab 20 – Bill Impacts) of the rate generator model for Woodstock Hydro also be updated to reflect this.

The OEB confirms that Hydro One's request to discontinue the ICM rate rider and the ICM regulatory account for Woodstock Hydro has been approved. Further, as requested by Hydro One, the affected tabs in the rate generator models attached to this Decision and Rate Order exclude the impacts of the ICM rate rider.

Hydro One also noted that the Tariff Schedules in Tab 19 of the rate generator models currently say, "Effective and Implementation Date January 1, 2022", but should say "Effective Date January 1, 2022 and Implementation Date February 1, 2022". Hydro One requested this update be made to all rate generator models. Hydro One clarified that these changes to the rate generator models do not affect the Tariffs of Rates and Charges that Hydro One has filed with its DRO (Attachments 11, 12, and 13) as they already reflect this information. Accordingly, Hydro One requested that the Tariffs of

Rates and Charges submitted by Hydro One with its DRO, on January 13, 2022, be approved as filed.

The OEB has reviewed Hydro One's DRO and supporting schedules, as submitted. The OEB approves the 2022 Tariff of Rates and Charges (see Appendix A), which are consistent with Hydro One's DRO as filed. Further, the rate generator models attached to this Decision and Rate Order reflect the effective date and implementation date of January 1, 2022 and February 1, 2022, respectively.

The bill impacts associated with this Decision and Rate Order for a typical residential customer are as follows:

- With respect to the Norfolk Power service area, there will be a monthly total bill increase of \$0.59 for a residential customer consuming 750 kWh.
- With respect to the Haldimand County Hydro service area, there will be a monthly total bill increase of \$4.12 for a residential customer consuming 750 kWh.
- With respect to the Woodstock Hydro service area, there will be a monthly total bill decrease of \$4.74 for a residential customer consuming 750 kWh.

These changes do not factor in the Ontario Energy Rebate or Harmonized Sales Tax.

2 CONTEXT AND PROCESS

Hydro One filed an application with the OEB to change its electricity distribution rates effective January 1, 2022.

The application was supported by pre-filed written evidence and completed Rate Generator Models. During the course of the proceeding, the applicant responded to interrogatories and, where required, updated and clarified the evidence. The OEB issued its Decision on December 16, 2021, and established the process for a DRO, as well as submissions on the DRO.

On January 7, 2022 Hydro One filed a Motion to Review and Vary (Motion) the Decision, which included a request for a stay of the portions of the Decision related to Account 1576 (Woodstock Hydro) for the 2016-2022 period, and the Account 1592 (All Acquired Utilities) aspects of the Decision, each pending the outcome of the Motion. Hydro One requested that otherwise the DRO should proceed as scheduled.

On January 12, 2022, the OEB issued a Notice of Hearing, Procedural Order No. 1 and Decision on Request for a Partial Stay¹, with respect to the Motion. Regarding the stay request, the OEB determined that Hydro One would not be required to file updated Account 1576 and Account 1592 balances with the DRO on January 13, 2022. The OEB further noted that a decision would be made with respect to the filing of these updated balances at a later date through the Motion proceeding.

Pursuant to the Decision, Hydro One filed a DRO on January 13, 2022. OEB staff filed its submission in response to the DRO on January 18, 2022. Hydro One filed its reply to OEB staff's submission on January 20, 2022, noting its requested changes discussed in the Overview section of this Decision and Rate Order.

3 DECISION ON THE DRAFT RATE ORDER

In its Decision, the OEB approved Hydro One's request to apply the Price Cap Incentive option to set rates for all Acquired Utilities, for 2022. The OEB approved January 1, 2022 as the effective date for the new rates, and permitted Hydro One to include in its DRO a calculation of forgone revenue from January 1, 2022 to January 31, 2022 with an implementation date of February 1, 2022. Hydro One included a forgone revenue calculation commencing February 1, 2022 and rate rider in its Tariff of Rates and Charges submitted with its DRO.

OEB staff filed its submission in response to the DRO on January 18, 2022, together with a revised set of Tariffs of Rates and Charges to include rate riders for "Rate Rider for Recovery of Incremental Capital - in effect until the effective date of the next cost of service based rate order" in Woodstock Hydro's service area and updated all the Acquired Utilities' rate generator models to be consistent with the Tariff of Rates and Charges.

In its reply submission on the DRO, Hydro One sought clarification on whether its request to discontinue the Woodstock Hydro ICM rate rider had been approved. If so, Hydro One requested the rate generator model for Woodstock Hydro also be updated to reflect this. Hydro One also noted that the implementation date noted in Tab 19 of the rate generator model for each of the Acquired Utilities should be corrected from January 1, 2022 to February 1, 2022.

The OEB agrees with Hydro One's submission. The approved Tariff of Rates and Charges excludes the Woodstock Hydro ICM rate rider.

The OEB approves the Tariff of Rates and Charges as filed by Hydro One on January 13, 2022 and has made the requested updates to the rate generator models to reflect the February 1, 2022 implementation date.

4 IMPLEMENTATION AND ORDER

THE ONTARIO ENERGY BOARD ORDERS THAT:

1. The Tariff of Rates and charges set out in Schedule A of this Decision and Rate Order is approved as final effective January 1, 2022, for implementation on February 1, 2022. The Tariff of Rates and Charges will apply to electricity consumed, or estimated to have been consumed, on and after January 1, 2022. Hydro One Networks Inc. shall notify its customers of the rate change no later than the delivery of the first bill reflecting the new final rates.

RESIDENTIAL SERVICE CLASSIFICATION

This classification applies to an account taking electricity at 750 volts or less where the electricity is used exclusively in a separate metered living accommodation. Customers shall be residing in single-dwelling units that consist of a detached house or one unit of a semi-detached, duplex, triplex or quadruplex house, with a residential zoning. Separately metered dwellings within a town house complex or apartment building also qualify as residential customers. All customers are single-phase. Class B consumers are defined in accordance with O. Reg. 429/04. Further servicing details are available in the distributor's Conditions of Service.

APPLICATION

The application of these rates and charges shall be in accordance with the Licence of the Distributor and any Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, which may be applicable to the administration of this schedule.

No rates and charges for the distribution of electricity and charges to meet the costs of any work or service done or furnished for the purpose of the distribution of electricity shall be made except as permitted by this schedule, unless required by the Distributor's Licence or a Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, or as specified herein.

Unless specifically noted, this schedule does not contain any charges for the electricity commodity, be it under the Regulated Price Plan, a contract with a retailer or the wholesale market price, as applicable.

GENERAL SERVICE 50 TO 4,999 KW SERVICE CLASSIFICATION

This classification applies to a non residential account whose average monthly maximum demand used for billing purposes is equal to or greater than, or is forecast to be equal to or greater than, 50 kW but less than 5,000 kW. Class A and Class B consumers are defined in accordance with O. Reg. 429/04. Further servicing details are available in the distributor's Conditions of Service.

APPLICATION

The application of these rates and charges shall be in accordance with the Licence of the Distributor and any Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, which may be applicable to the administration of this schedule.

No rates and charges for the distribution of electricity and charges to meet the costs of any work or service done or furnished for the purpose of the distribution of electricity shall be made except as permitted by this schedule, unless required by the Distributor's Licence or a Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, or as specified herein.

This rate rider is to be consistently applied for the entire period to the sunset date of the rate rider. In addition, this rate rider is applicable to all new non-RPP Class B customers.
