Association Mandate:

AMPCO is a not-for-profit consumer interest advocacy organization. Its mission is industrial electricity rates that are affordable, competitive and fair.

Association Membership:

AMPCO's members represent Ontario's major industries: forestry, chemical, mining and minerals, steel, petroleum products, cement, automotive and manufacturing and business consumers in general. AMPCO members are major investors, major employers and a major part of the communities in which they operate, across Ontario. Membership is available for industrial companies with operations in Ontario and with minimum average monthly demand greater than or equal to 1 MW.
