Application for Electricity Generation Licence by Kap Power Corp. regarding the Kapuskasing Power Plant: EB-2021-0298

Dear Ms. Gocool:

1. We are in receipt of your email dated November 30, 2021. URICA Energy Management Corporation provides a response to your information request, on behalf of Kap Power Corp. ("Kap Power") below.

Question: Following up from my email this morning, in order to process the electricity generation licence for Kap Power Corp., the OEB requests that both Atlantic Power Limited Partnership (EG-2003-0096) and Atlantic Power Services LP (EG-2011-0348) to submit licence amendment requests to remove Kapuskasing Power Plant, as a generation facility listed in Schedule 1 of their licences.

- 2. In accordance with the request of the Ontario Energy Board ("Board"), on December 3, 2021, Atlantic Power Corporation submitted a written request to the Board seeking to amend Schedule 1 of Electricity Generation Licence EG-2003-0096 to remove reference to ownership of the Kapuskasing Power Plant, and to amend Schedule 1 of Electricity Generation Licence EG-2011-0348 to remove reference to operation of the Kapuskasing Power Plant.
- 3. Attached, for your reference, is a copy of the written request submitted to the Board Secretary by Atlantic Power Corporation on behalf of Atlantic Power Limited Partnership and Atlantic Power Services Canada LP.

Atlantic Power Corporation is a Massachusetts based independent power producer with operations throughout North America (https://www.atlanticpower.com). Until recently, the company owned and operated 5 generation facilities in Ontario, including the North Bay and Kapuskasing power plants. These stations both ceased operation on December 31, 2016 and have remained in a mothballed state since then. On February 23, 2021, Atlantic Power entered in to an agreement to sell these facilities to SNS Power Corp. The sale was completed on May 20, 2021, and the sell agreement was referenced in Atlantic Power Corporation's 10-Q filing for the period ending March 31, 2021 which can be found at this link:

As a result of this sale, Atlantic Power Corporation is seeking to amend its two Electricity Generating Licences with the OEB;

1) Electricity Generation Licence # EG-2011-0348 Atlantic Power Services Canada LP (the operator):

This Licence authorizes the Licencee to operate Generation Stations. The following facilities should be removed from Schedule 1 of this Licence:

- Kapuskasing Power Plant, Kapuskasing, Ontario;
- North Bay Power Plant, North Bay, Ontario; and

Electricity Generation Licence # EG-2003-0096 for Atlantic Power Limited Partnership (the owner)

This Licence authorizes the Licencee to own Generation Stations. The following facilities should be removed from Schedule 1 of this Licence:

- The ownership of North Bay Power Plant with an installed capacity of 61.4 MW located at 4001 Highway 11 North, North Bay, Ontario.
- The ownership of Kapuskasing Power Plant with an installed capacity of 61.4 MW located at 47 Gough Road, Kapuskasing, Ontario.

Note that the purchaser, SNS Power Corp., has already restructured ownership of the assets, and from my understanding they are currently held by Validus Power Corporation ("Validus Power"). Bay Power Corp. and Kap Power Corp., wholly owned subsidiaries of Validus Power, have made applications to the OEB for new licences to own and operate the Kapuskasing Power Plant (in EB-2021-0298) and to own and operate the North Bay Power Plant (in EB-2021-0295). The OEB's Natasha Gocool (Analyst, Industry Policy & Compliance) has recently requested that Atlantic Power submit the Licence amendment requests to the Registrar's Office, as soon as possible, in order to continuing processing the electricity generation Licence application for Kap Power Corp.
