Attached please find AMPCO's cost claim for the above proceeding. OPG's application was vast and complex, covering five years of revenue requirement (2022-2026). AMPCO aimed to focus its efforts on the key cost drivers and material issues that contributed the most to the proposed increase in Nuclear Payment Amounts over the Test Period. AMPCO was active in all key aspects of the proceeding including written interrogatories, technical conference, settlement conference, issues day, motions day, oral hearing and written submissions.

On an ongoing basis throughout the proceeding, AMPCO worked collaboratively with other intervenors to deliberate the issues, avoid duplication and increase efficiency. AMPCO undertook a key role on nuclear capital projects and rate base additions, and a lead role on the D2O project which involved doing an in-depth review of the evidence in the current and past proceedings. AMPCO filed the majority of interrogatories on the D2O project and undertook a comprehensive and detailed analysis of the project and OPG's management of the project. AMPCO was contributory to the OEB's determination that SMR-related costs are within scope.

With respect to the unsettled issues, which included the D2O project, AMPCO worked closely with the Consumers Council of Canada, sharing Counsel for cross examination and submitting a joint Final Argument. AMPCO/CCC took the lead on the D2O issue which resulted in limited cross examination from other parties. Working together increased our joint understanding of the issues, facilitated detailed submissions and resulted in reduced costs for both AMPCO and the Council.
