



Enbridge Gas Inc.

Application for leave to construct a natural gas pipeline and for approval to drill two natural gas wells, in the Township of St. Clair in Lambton County

PROCEDURAL ORDER NO. 1 February 18, 2022

On December 15, 2021, Enbridge Gas Inc. (Enbridge Gas) filed an application with the Ontario Energy Board (OEB) for the Coveny and Kimball-Colinville Well Drilling Project. Enbridge Gas's application has been filed pursuant to section 40(1) of the *Ontario Energy Board Act*, 1998, S.O. 1998, c. 15, (Schedule B) (OEB Act).

As required under the OEB Act, Enbridge Gas has applied to the Minister of Northern Development, Mines, Natural Resources and Forestry (Minister) for licences to drill an A-1 observation well in its Coveny Storage Pool and an injection/withdrawal well in its Kimball-Colinville Storage Pool. Pursuant to section 40(1) of the OEB Act, the Minister referred the applications to the OEB. The OEB is required to report to the Minister before the Minister can issue the licences to drill the wells and Enbridge Gas has requested a favourable report from the OEB.

Being eligible to apply for recovery of costs is not a guarantee of recovery of any costs claimed. Cost awards are made by way of OEB order at the end of a hearing.

The list of parties in this proceeding is attached as Schedule A to this Procedural Order.

Interrogatories

Parties should consult sections 26 and 27 of the OEB's *Rules of Practice and Procedure* regarding required naming and numbering conventions for interrogatories. Parties should focus their interrogatories on material issues and on issues that are within the scope of the OEB's review in this proceeding. In preparing their interrogatories, parties should consult the OEB's standard <u>Issues List</u> for natural gas leave to construct applications.

It is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

IT IS THEREFORE ORDERED THAT:

- 1. OEB staff and intervenors shall request any relevant information and documentation from Enbridge Gas that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on all parties by, March 2, 2022.
- 2. Enbridge Gas shall file with the OEB complete written responses to all interrogatories and serve them on intervenors by, **March 9, 2022**.
- 3. Any written submissions from OEB staff and intervenors, shall be filed with the OEB and served on all parties by, **March 18, 2022**.
- 4. Any written reply submissions from Enbridge Gas shall be filed with the OEB and served on intervenors by, **March 24, 2022**.

Parties are responsible for ensuring that any documents they file with the OEB, such as applicant and intervenor evidence, interrogatories and responses to interrogatories or any other type of document, do not include personal information (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's <u>Rules of Practice and Procedure</u>.
