# 1 OVERVIEW

The Ontario Energy Board is approving changes to the rates that ERTH Power Corporation (ERTH Power) charges to distribute electricity to its customers, effective May 1, 2022.

As a result of this Decision, there will be a monthly total bill increase of \$0.97 in the Main rate zone, and \$2.87 in the Goderich rate zone, for a residential customer consuming 750 kWh, effective May 1, 2022. The changes do not factor in applicable taxes or the Ontario Electricity Rebate.

## 2 CONTEXT AND PROCESS

ERTH Power filed its application on November 23, 2021 under section 78 of the *Ontario Energy Board Act, 1998* and in accordance with Chapter 3 of the OEB's [Filing Requirements for Incentive Rate-Setting Applications](#). ERTH Power maintains two separate rate zones. These are the Main rate zone, which represents the legacy service territory of the former Erie Thames Powerlines, and the Goderich rate zone, which represents the legacy service territory of the former West Coast Huron Energy.<sup>1</sup> ERTH Power will continue to operate with two rate zones until such time as rates are rebased and approved on a harmonized basis by the OEB.

ERTH Power's application for the Main rate zone was based on the Price Cap Incentive Rate-setting (Price Cap IR) option. The Price Cap IR option is one of three incentive rate-setting mechanisms (IRM) approved by the OEB.<sup>2</sup> It involves the setting of rates through a cost of service application in the first year and mechanistic price cap adjustments which may be approved through IRM applications in each of the ensuing four adjustment years.

ERTH Power's application for the Goderich rate zone was based on the Annual IR Index (Annual IR) option. Under this methodology, existing rates are subject to an annual price cap adjustment. Distributors under the Annual IR are not required to periodically set base rates using a cost of service process, but they are required to apply the highest stretch factor in the price cap adjustment.

The OEB follows a standardized and streamlined process for hearing IRM applications filed under Price Cap IR or the Annual IR option. In each adjustment year of a Price Cap IR or Annual IR term, the OEB prepares a Rate Generator Model that includes, as a placeholder, information from the distributor's past proceedings and annual reporting requirements. A distributor will then review, complete, and include the model with its application, and may update the model during the proceeding to make any necessary corrections or to incorporate new rate-setting parameters as they become available.

ERTH Power serves approximately 23,000 mostly residential and commercial electricity customers in Port Stanley, Aylmer, Belmont, Ingersoll, Thamesford, Otterville, Norwich, Burgessville, Beachville, Embro, Tavistock, Mitchell, Dublin, Clinton, and the Town of Goderich.

The application was supported by pre-filed written evidence and completed Rate Generator Models and as required during the proceeding, ERTH Power updated and clarified the evidence.

### 3 DECISION OUTLINE

Each of the following issues is addressed in this Decision, together with the OEB's findings.

- Annual Adjustment Mechanism
- Shared Tax Adjustments
- Retail Transmission Service Rates
- Group 1 Deferral and Variance Accounts

Instructions for implementing ERTH Power's new rates and charges are set out in the final section of this Decision.

This Decision does not address rates and charges approved by the OEB in prior proceedings, such as specific service charges<sup>3</sup> and loss factors, which are out of scope of an IRM proceeding and for which no further approvals are required to continue to include them on the distributor's Tariff of Rates and Charges.

## 4 ANNUAL ADJUSTMENT MECHANISM

ERTH Power has applied to change its rates, effective May 1, 2022, based on a mechanistic rate adjustment using the OEB-approved **inflation minus X-factor** formula applicable to IRM applications. The adjustment applies to distribution rates (fixed and variable) uniformly across all customer classes.<sup>4</sup>

The components of the Price Cap IR adjustment formula applicable to ERTH Power's Main rate zone are set out in Table 4.1 below. Inserting these components into the formula results in a 3.00% increase to ERTH Power's rates: **3.00% = 3.30% - (0.00% + 0.30%)**.

The components of the Annual IR adjustment formula applicable to ERTH Power's Goderich rate zone are set out in Table 4.2 below. Inserting these components into the formula results in a 2.70% increase to ERTH Power's rates: **2.70% = 3.30% - (0.00% + 0.60%)**.

An inflation factor of 3.30% applies to all IRM applications for the 2022 rate year.

On August 6, 2021, the OEB issued a Notice on its own motion to initiate a proceeding to consider the inflation factor to be used to set rates for electricity transmitters and electricity and natural gas distributors for the year 2022. The OEB issued its Decision and Order on November 18, 2021, establishing the 2022 inflation factor.

The X-factor is the sum of the productivity factor and the stretch factor. It is a productivity offset that varies among different groupings of distributors. Subtracting the X-factor from inflation ensures that rates decline in real, constant-dollar terms, providing distributors with a tangible incentive to improve efficiency or else experience declining net income. The productivity component of the X-factor is based on industry conditions over a historical study period and applies to all IRM applications for the 2022 rate year. The stretch factor component of the X-factor is distributor specific. The OEB has established five stretch factor groupings, ranging from 0.00% to 0.60%. The stretch factor assigned to any particular distributor is generally based on the distributor's total cost performance as benchmarked against other distributors in Ontario. The stretch factor assigned to ERTH Power's Main rate zone is 0.30%, resulting in a rate adjustment of 3.00%. As the rates for ERTH Power's Goderich rate zone are being adjusted under the Annual IR option, it is required to apply the highest stretch factor in the price cap adjustment. Accordingly, the stretch factor assigned to ERTH Power's Goderich's rate zone is 0.60%, resulting in a rate adjustment of 2.70%.

## Findings

ERTH Power's request for a 3.00% rate adjustment for the Main rate zone and 2.70% rate adjustment for the Goderich rate zone is in accordance with the annually updated parameters set by the OEB. The adjustment is approved, and ERTH Power's new rates shall be effective May 1, 2022.

## 5 SHARED TAX ADJUSTMENTS (GODERICH RATE ZONE)

In any adjustment year of an IRM term, a change in legislation may result in a change to the amount of taxes payable by a distributor. The impacts of such legislated tax changes are shared equally between shareholders and customers.<sup>8</sup> The shared tax change amount, whether in the form of a credit or a debit, will be assigned to customer rate classes in the same proportions as the OEB-approved distribution revenue by rate class from the distributor's last cost of service proceeding.

The application identifies a total tax decrease of \$6,503 for the Goderich rate zone, resulting in a shared amount of \$3,252 to be refunded to ratepayers in the Goderich rate zone.

This allocated tax sharing amount does not produce a rate rider to the fourth decimal place, in one or more rate classes. In such situations where the Rate Generator Model does not compute rate riders, distributors are required to transfer the entire OEB-approved tax sharing amount into the Disposition and Recovery of Regulatory Balances Control Account (Account 1595) for disposition at a later date.

### Findings

The OEB approves the tax refund of \$3,252 for the Goderich rate zone.

As the allocated tax sharing amount does not produce a rate rider in one or more rate classes, the OEB directs ERTH Power to record the credit amount of \$3,252 into Account 1595 - Sub-account Principal Balances Approved for Disposition in 2022 for the Goderich rate zone.

## 6 RETAIL TRANSMISSION SERVICE RATES

ERTH Power's Main rate zone is partially embedded within Hydro One Networks Inc.'s distribution system; the Goderich rate zone is transmission connected.

To recover its cost of transmission services, ERTH Power requests approval to adjust the retail transmission service rates (RTSRs) that it charges its customers in accordance with the Uniform Transmission Rates (UTRs) and host distributor RTSRs currently in effect.

### Findings

ERTH Power's proposed adjustment to its RTSRs for each rate zone is approved. The RTSRs were adjusted based on the current OEB-approved UTRs and host-RTSRs.<sup>9</sup>

UTRs and host-RTSRs are typically approved annually by the OEB. In the event that new UTRs or host-RTSRs take effect during ERTH Power's 2022 rate year, any resulting differences (from the prior-approved UTRs and host-RTSRs) are to be captured in Retail Settlement Variance Accounts 1584 (Retail Transmission Network Charge) and 1586 (Retail Transmission Connection Charge).

## 7 GROUP 1 DEFERRAL AND VARIANCE ACCOUNTS

In each year of an IRM term, the OEB will review a distributor's Group 1 deferral and variance accounts to determine whether those balances should be disposed. OEB policy states that Group 1 account balances should be disposed if they exceed, on a net basis (as a debit or credit), a pre-set disposition threshold of \$0.001 per kWh, unless a distributor can justify why balances should not be disposed.<sup>10</sup> If the balance does not exceed the threshold, a distributor may still request disposition.

The 2020 year-end net balance for the Main rate zone's Group 1 accounts (excluding Accounts 1588 and 1589) that are eligible for disposition, including interest projected to April 30, 2022, is a debit of \$525,347, and pertains to variances accumulated during the 2019 and 2020 calendar years. This amount represents a total debit claim of \$0.0009 per kWh, which does not exceed the disposition threshold, and ERTH Power has not requested disposition.

The 2020 year-end net balance for the Goderich rate zone's Group 1 accounts (excluding Accounts 1588 and 1589) that are eligible for disposition, including interest projected to April 30, 2022, is a debit of \$11,977, and pertains to variances accumulated during the 2020 calendar year. This amount represents a total debit claim of \$0.0001 per kWh, which does not exceed the disposition threshold, and ERTH Power has not requested disposition.

In each of ERTH Power's 2020 and 2021 rates proceedings, the OEB expressed concerns with ERTH Power's Account 1588 and Account 1589 balances for both rate zones. In ERTH Power's IRM proceeding for 2021 rates, ERTH Power indicated that it planned to conduct a further review of Account 1588 and Account 1589, and that it was not requesting disposition of those accounts. In the associated decision and rate order, the OEB accepted ERTH Power's request to defer disposition of Accounts 1588 and 1589. The OEB also directed ERTH Power to address several specific items as part of its 2022 IRM application and to provide support for any material adjustments made to the Account 1588 and Account 1589 balances prior to requesting disposition.<sup>11</sup>

In this proceeding, ERTH Power stated that it has determined that there is a billing inconsistency with respect to one of its wholesale metering points billed on its Independent Electricity System Operator (IESO) invoice and is in the process of reviewing the findings with IESO staff.<sup>12</sup> As a result, ERTH Power has requested to not dispose of Account 1588 and Account 1589 balances in the current proceeding, for

either rate zone.<sup>13</sup> In response to an OEB staff question, ERTH Power explained that while the billing inconsistency only applies to the Main rate zone, ERTH Power prefers to defer disposition of its Account 1588 and Account 1589 balances in both rate zones to ensure the accuracy of balances allocated to each rate zone, as the entire IESO invoice is impacted.<sup>14</sup>

ERTH Power further explained that the billing inconsistency needs to be addressed prior to correcting the issues noted by the OEB in its 2020 and 2021 IRM decisions.<sup>15</sup> ERTH Power confirmed that it expects it will be in a position to request disposition of its Group 1 account balances for both rate zones as part of its 2023 rates application.<sup>16</sup>

## Findings

With respect to the Group 1 accounts other than Accounts 1588 and 1589, the OEB finds that the account balances for each rate zone appear reasonable. No disposition is required at this time, as the disposition threshold has not been exceeded and the distributor did not request disposition.

The OEB accepts ERTH Power's proposal to defer disposition of its Group 1 accounts for both rate zones. The OEB expects ERTH Power to bring forward its Group 1 account balances for the OEB's consideration as part of its application for 2023 rates, along with the outcomes of its billing inconsistency investigation with the IESO. The OEB further expects that the specific directions provided by the OEB in ERTH Power's decision and rate orders for 2020 and 2021 rates, respectively, be addressed and that the outcomes associated with those directions also be included in ERTH Power's application for 2023 rates.

## 8 IMPLEMENTATION

This Decision is accompanied by Rate Generator Models, applicable supporting models, and a Tariff of Rates and Charges (Schedule A). The Rate Generator Models also incorporate the rates set out in Table 8.1.

**Table 8.1: Regulatory Charges**

Rate	per kWh
Rural or Remote Electricity Rate Protection (RRRP)	\$0.0005
Wholesale Market Service (WMS) billed to Class A and B Customers	\$0.0030
Capacity Based Recovery (CBR) billed to Class B Customers	\$0.0004

Each of these rates is a component of the “Regulatory Charge” on a customer’s bill, established annually by the OEB through a separate, generic order. The RRRP, WMS and CBR rates were set by the OEB on December 16, 2021.<sup>17</sup>

The Smart Metering Entity Charge is a component of the “Distribution Charge” on a customer’s bill, established by the OEB through a separate order. The Smart Metering Entity Charge was set by the OEB on March 1, 2018.<sup>18</sup>

In the *Report of the Board: Review of Electricity Distribution Cost Allocation Policy*,<sup>19</sup> the OEB indicated that it will review the default province-wide microFIT charge annually to ensure it continues to reflect actual costs in accordance with the established methodology. On January 26, 2022, the OEB issued a letter advising electricity distributors that the microFIT charge shall remain at \$4.55 for the duration of the 2022 calendar year.

The application of these rates and charges shall be in accordance with the Licence of the Distributor and any Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, which may be applicable to the administration of this schedule.

No rates and charges for the distribution of electricity and charges to meet the costs of any work or service done or furnished for the purpose of the distribution of electricity shall be made except as permitted by this schedule, unless required by the Distributor's Licence or a Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, or as specified herein.

Unless specifically noted, this schedule does not contain any charges for the electricity commodity, be it under the Regulated Price Plan, a contract with a retailer or the wholesale market price, as applicable. ### GENERAL SERVICE 50 TO 999 KW SERVICE CLASSIFICATION

This classification refers to the supply of electrical energy to General Service customers requiring a connection with a connected load, or whose average monthly maximum demand used for billing purposes, is equal to or greater than 50 kW but less than 1000 kW. Class B consumers are defined in accordance with O. Reg. 429/04. Further servicing details are available in the distributor's Conditions of Service.

#### APPLICATION

The application of these rates and charges shall be in accordance with the Licence of the Distributor and any Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, which may be applicable to the administration of this schedule.

No rates and charges for the distribution of electricity and charges to meet the costs of any work or service done or furnished for the purpose of the distribution of electricity shall be made except as permitted by this schedule, unless required by the Distributor's Licence or a Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, or as specified herein.

Unless specifically noted, this schedule does not contain any charges for the electricity commodity, be it under the Regulated Price Plan, a contract with a retailer or the wholesale market price, as applicable. In addition, the charges in the MONTHLY RATES AND CHARGES -- Regulatory Component of this schedule do not apply to a customer that is an embedded wholesale market participant.

If included in the following listing of monthly rates and charges, the rate rider for the disposition of WMS - Sub-account CBR Class B is not applicable to wholesale market participants (WMP), customers that transitioned between Class A and Class B during the variance account accumulation period, or to customers that were in Class A for the entire period. Customers who transitioned are to be charged or refunded their share of the variance disposed through customer specific billing adjustments. This rate rider is to be consistently applied for the entire period to the sunset date of the rate rider. In addition, this rate rider is applicable to all new Class B customers.

If included in the following listing of monthly rates and charges, the rate rider for the disposition of Global Adjustment is only applicable to non-RPP Class B customers. It is not applicable to WMP, customers that transitioned between Class A and Class B during the variance account accumulation period, or to customers that were in Class A for the entire period. Customers who transitioned are to be charged or refunded their share of the variance disposed through customer specific billing adjustments. This rate rider is to be consistently applied for the entire period to the sunset date of the rate rider. In addition, this rate rider is applicable to all new non-RPP Class B customers.

It should be noted that this schedule does not list any charges, assessments, or credits that are required by law to be invoiced by a distributor and that are not subject to Ontario Energy Board approval, such as the Global Adjustment and the HST.
