

1 OVERVIEW

The Ontario Energy Board is approving changes to the rates that Newmarket-Tay Power Distribution Ltd. (Newmarket-Tay Power) charges to distribute electricity to its customers, effective May 1, 2022.

As a result of this Decision, there will be a monthly total bill increase of \$3.86 in the Newmarket-Tay rate zone, and \$4.11 in the Midland rate zone, for a residential customer consuming 750 kWh, effective May 1, 2022. These changes do not factor in applicable taxes or the Ontario Electricity Rebate.



2 CONTEXT AND PROCESS

On August 23, 2018, the OEB granted Newmarket-Tay Power approval to purchase and amalgamate with Midland Power Utility Corporation. As part of the amalgamation approval, the OEB determined that Newmarket-Tay Power would maintain two separate rate zones, the Newmarket-Tay Rate Zone and the Midland Rate Zone, for a ten-year deferral period, at which point Newmarket-Tay Power's rates will be rebased.

Newmarket-Tay Power serves approximately 45,000 mostly residential and commercial electricity customers in the Township of Newmarket and Township of Tay in the Newmarket-Tay rate zone and approximately 7,400 mostly residential and commercial electricity customers in the Town of Midland in the Midland rate zone.

Newmarket-Tay Power filed its application on October 25, 2021 under section 78 of the Ontario Energy Board Act, 1998 and in accordance with Chapter 3 of the OEB's Filing Requirements for Incentive Rate-Setting Applications. The application was based on the Annual IR Index (Annual IR) option for the Newmarket-Tay rate zone and the Price Cap Incentive Rate-setting (Price Cap IR) option for the Midland rate zone.

The Price Cap IR option is one of three incentive rate-setting mechanisms (IRM) approved by the OEB.² It involves the setting of rates through a cost of service application in the first year and mechanistic price cap adjustments which may be approved through IRM applications in each of the ensuing four adjustment years.

Under the Annual IR methodology, existing rates are subject to an annual price cap adjustment. Distributors under the Annual IR are not required to periodically set base rates using a cost of service process, but they are required to apply the highest stretch factor in the price cap adjustment.

The OEB follows a standardized and streamlined process for hearing IRM applications. In each adjustment year, the OEB prepares a Rate Generator Model that includes, as a placeholder, information from the distributor's past proceedings and annual reporting requirements. A distributor will then review, complete, and include the model with its application, and may update the model during the proceeding to make any necessary corrections or to incorporate new rate-setting parameters as they become available.

The application was supported by pre-filed written evidence and completed Rate Generator Models and as required during the proceeding, Newmarket-Tay Power updated and clarified the evidence.

3 DECISION OUTLINE

Each of the following issues is addressed in this Decision, together with the OEB's findings.

- Annual Adjustment Mechanism
- Shared Tax Adjustments
- Retail Transmission Service Rates
- Group 1 Deferral and Variance Accounts
- Lost Revenue Adjustment Mechanism Variance Account Balance

Instructions for implementing Newmarket-Tay Power's new rates and charges are set out in the final section of this Decision.

This Decision does not address rates and charges approved by the OEB in prior proceedings, such as specific service charges³ and loss factors, which are out of scope of an IRM proceeding and for which no further approvals are required to continue to include them on the distributor's Tariff of Rates and Charges.

4 ANNUAL ADJUSTMENT MECHANISM

Newmarket-Tay Power has applied to change its rates, effective May 1, 2022, based on a mechanistic rate adjustment using the OEB-approved **inflation minus X-factor** formula applicable to IRM applications. The adjustment applies to distribution rates (fixed and variable) uniformly across all customer classes.⁴

The components of the Annual IR adjustment formula applicable to Newmarket-Tay rate zone are set out in the table below. Inserting these components into the formula results in a 2.70% increase to Newmarket-Tay Power's rates: **2.70% = 3.30% - (0.00% + 0.60%)**.

The components of the Price Cap IR adjustment formula applicable to the Midland rate zone are set out in the table below. Inserting these components into the formula results in a 3.15% increase to Newmarket-Tay Power's rates: **3.15% = 3.30% - (0.00% + 0.15%)**.

An inflation factor of 3.30% applies to all IRM applications for the 2022 rate year.

On August 6, 2021, the OEB issued a Notice on its own motion to initiate a proceeding to consider the inflation factor to be used to set rates for electricity transmitters and electricity and natural gas distributors for the year 2022. The OEB issued its Decision and Order on November 18, 2021, establishing the 2022 inflation factor.

The X-factor is the sum of the productivity factor and the stretch factor. It is a productivity offset that varies among different groupings of distributors. Subtracting the X-factor from inflation ensures that rates decline in real, constant-dollar terms, providing distributors with a tangible incentive to improve efficiency or else experience declining net income. The productivity component of the X-factor is based on industry conditions over a historical study period and applies to all IRM applications for the 2022 rate year. The stretch factor component of the X-factor is distributor specific. The OEB has established five stretch factor groupings, ranging from 0.00% to 0.60%. The stretch factor assigned to any particular distributor is generally based on the distributor's total cost performance as benchmarked against other distributors in Ontario. However, as the Newmarket-Tay rate zone is filing under the Annual IR, it is required to apply the highest stretch factor. Accordingly, the stretch factor assigned to Newmarket-Tay rate zone is 0.60%, resulting in a rate adjustment of 2.70%. The stretch factor assigned to the Midland rate zone is 0.15%, resulting in a rate adjustment of 3.15%.

Findings

Newmarket-Tay Power's request for a 2.70% rate adjustment for the Newmarket-Tay rate zone and a 3.15% rate adjustment for the Midland rate zone is in accordance with the annually updated parameters set by the OEB. The adjustments are approved, and Newmarket-Tay Power's new rates shall be effective May 1, 2022.

5 SHARED TAX ADJUSTMENTS

In any adjustment year of an IRM term, a change in legislation may result in a change to the amount of taxes payable by a distributor. The impacts of such legislated tax changes are shared equally between shareholders and customers.⁸ The shared tax change amount, whether in the form of a credit or a debit, will be assigned to customer rate classes in the same proportions as the OEB-approved distribution revenue by rate class from the distributor's last cost of service proceeding.

The application identifies a total tax decrease of \$82,190 for the Newmarket-Tay rate zone, resulting in a shared amount of \$41,095 to be refunded to ratepayers.

The application identifies a total tax increase of \$2,034 fo the Midland rate zone, resulting in a shared amount of \$1,017 to be collected from ratepayers.

For the Midland rate zone, this allocated tax sharing amount does not produce a rate rider to the fourth decimal place, in one or more rate classes. In such situations where the Rate Generator Model does not compute rate riders, distributors are required to transfer the entire OEB-approved tax sharing amount into the Disposition and Recovery of Regulatory Balances Control Account (Account 1595) for disposition at a later date.

Findings

The OEB approves the tax refund of \$41,095 for the Newmarket-Tay rate zone.

The amount shall be refunded through a fixed monthly rate rider for residential customers, and through riders calculated on a volumetric basis for all other customers over a one-year period from May 1, 2022, to April 30, 2023.

The OEB also approves the tax charge of \$1,017 for the Midland rate zone.

As this allocated tax sharing amount does not produce a rate rider in one or more rate classes, the OEB directs Newmarket-Tay Power to record the debit amount of \$1,017 into Account 1595 - Sub-account Principal Balances Approved for Disposition in 2022.

6 RETAIL TRANSMISSION SERVICE RATES

The Newmarket-Tay rate zone is partially embedded within Hydro One Networks Inc.'s (Hydro One) distribution system and the Midland rate zone is fully embedded with within Hydro One's distribution system.

To recover its cost of transmission services, Newmarket-Tay Power requests approval to adjust the retail transmission service rates (RTSRs) that it charges its customers in accordance with the Uniform Transmission Rates (UTRs) and host distributor RTSRs currently in effect.

Findings

Newmarket-Tay Power's proposed adjustment to its RTSRs is approved. The RTSRs were adjusted based on the current OEB-approved UTRs and host-RTSRs.⁹

UTRs and host-RTSRs are typically approved annually by the OEB. In the event that new UTRs or host-RTSRs take effect during Newmarket-Tay Power's 2022 rate year, any resulting differences (from the prior-approved UTRs and host-RTSRs) are to be captured in Retail Settlement Variance Accounts 1584 (Retail Transmission Network Charge) and 1586 (Retail Transmission Connection Charge).

7 GROUP 1 DEFERRAL AND VARIANCE ACCOUNTS

In each year of an IRM term, the OEB will review a distributor's Group 1 deferral and variance accounts in order to determine whether those balances should be disposed. OEB policy states that Group 1 account balances should be disposed if they exceed, on a net basis (as a debit or credit), a pre-set disposition threshold of \$0.001 per kWh, unless a distributor justifies why balances should not be disposed. ¹⁰ If the net balance does not exceed the threshold, a distributor may still request disposition.

The 2020 year-end net balance for Newmarket-Tay Power Group 1 accounts in the Newmarket-Tay rate zone eligible for disposition, including interest projected to April 30, 2022, is a credit of \$274,013, and pertains to variances accumulated during the 2020 calendar year. This amount represents a total credit claim of \$0.0004 per kWh, which does not exceed the disposition threshold. Newmarket-Tay Power has requested disposition of this amount over a one-year period, with one exception. Newmarket-Tay Power has requested that the Global Adjustment (GA) rate rider charged to the Street Lighting rate class be disposed of over two years, in order to mitigate the total bill impact for that class.

The 2020 year-end net balance for Newmarket-Tay Power's Group 1 accounts in the Midland rate zone eligible for disposition, including interest projected to April 30, 2022, is a debit of \$942,794, and pertains to variances accumulated during the 2020 calendar year. This amount represents a total debit claim of \$0.0053 per kWh, which exceeds the disposition threshold. Newmarket-Tay Power has requested disposition of this amount over a one-year period.

Included in the Group 1 accounts are certain variances related to costs that are paid for by a distributor's customers on different bases, depending on their classification. Namely, "Class A" customers, who participate in the Industrial Conservation Initiative, pay for GA charges based on their contribution to the five highest Ontario demand peaks over a 12-month period. "Class B" customers pay for GA charges based on their monthly consumption totals, either as a standalone charge or embedded in the Regulated Price Plan (RPP).¹¹ A similar mechanism applies to Class A and Class B customers for Capacity Based Recovery (CBR) charges.¹² The balance in the GA variance account is attributable to non-RPP Class B customers and is disposed through

a separate rate rider. The balance in the CBR Class B variance account is attributable to all Class B customers.

In each of its rate zones, Newmarket-Tay Power had Class A customers during the period in which variances accumulated so it has applied to have the balance of the CBR Class B variance account disposed through a separate rate rider for Class B customers to ensure proper allocation between Class A and Class B customers.

For the Newmarket-Tay rate zone, during the period in which variances accumulated, Newmarket-Tay Power had customers transition between Class A and Class B. Under the general principle of cost causality, customer groups that cause variances which are recorded in Group 1 accounts should be responsible for paying (or receiving credits) for their disposal. Newmarket-Tay Power has proposed to allocate a portion of the GA and CBR Class B balances to its transition customers, based on their customer-specific consumption levels. ¹³ The amounts allocated to each transition customer are proposed to be recovered (or refunded, as applicable), by way of 12 equal monthly installments.

Findings

The balances proposed for disposition reconcile with the amounts reported as part of the OEB's *Electricity Reporting and Record-Keeping Requirements*.

The OEB approves the disposition of a credit balance of \$274,013 as of December 31, 2020, including interest projected to April 30, 2022 for Group 1 accounts on a final basis for the Newmarket-Tay rate zone.

Table 7.1 identifies the principal and interest amounts, which the OEB approves for disposition.

The OEB approves the disposition of a debit balance of \$942,794 as of December 31, 2020, including interest projected to April 30, 2022 for Group 1 accounts on a final basis for the Midland rate zone.

The balance of each of the Group 1 accounts approved for disposition shall be transferred to the applicable principal and interest carrying charge sub-accounts of Account 1595. Such transfer shall be pursuant to the requirements specified in the *Accounting Procedures Handbook for Electricity Distributors.* ¹⁴ The date of the transfer must be the same as the effective date for the associated rates, which is generally the start of the rate year.

The OEB approves these balances to be disposed through final rate riders, charges, or payments, as calculated in the Rate Generator Models. With the exception of the GA rate rider charged to the Street Lighting rate class in the Newmarket-Tay rate zone, the final rate riders, charges, and payments, as applicable, will be in effect over a one-year

period from May 1, 2022 to April 30, 2023.¹⁵ The GA rate rider charged to the Street Lighting rate class in the Newmarket-Tay rate zone will be in in effect over a two-year period from May 1, 2022 to April 30, 2024 in order to mitigate the total bill impact for that class.

8 LOST REVENUE ADJUSTMENT MECHANISM VARIANCE ACCOUNT

The OEB utilizes a Lost Revenue Adjustment Mechanism Variance Account (LRAMVA), which captures a distributor's revenue implications resulting from differences between actual and forecast conservation savings included in its last OEB-approved load forecast.¹⁶

Distributors previously delivered conservation and demand management (CDM) programs to their customers through the Conservation First Framework (CFF) that began on January 1, 2015 until March 20, 2019, when the CFF was revoked. The OEB provided direction to distributors seeking to claim program savings up to December 31, 2021 related to CFF programs or other conservation programs they delivered.

Newmarket-Tay Power has applied to dispose of its LRAMVA debit balance of \$435,306. The balance consists of lost revenues in 2020 from CDM programs delivered during the period from 2011 to 2020 in the Newmarket-Tay rate zone and 2014 to 2020 in the Midland rate zone, as well as carrying charges. The actual conservation savings claimed by Newmarket-Tay Power under the CFF were validated with reports from the IESO, project level savings files, or both.

For the Newmarket-Tay rate zone, the full impact of conservation savings is being claimed, as there were no forecasted conservation savings included in its last OEB-approved load forecast. ¹⁹ For the Midland rate zone, actual conservation savings were compared against forecasted conservation savings of 3,299,236 kWh included in its last OEB-approved load forecast. ²⁰

Findings

The OEB finds that Newmarket-Tay Power's LRAMVA balance has been calculated in accordance with the OEB's CDM-related guidelines and LRAMVA policy. The OEB approves the disposition of Newmarket-Tay Power's LRAMVA debit balance of \$435,306, as set out in Table 8.1 below.

9 IMPLEMENTATION

This Decision is accompanied by Rate Generator Models, applicable supporting models, and a Tariff of Rates and Charges (Schedule A). The Rate Generator Models also incorporate the rates set out in Table 9.1.

Each of these rates is a component of the "Regulatory Charge" on a customer's bill, established annually by the OEB through a separate, generic order. The RRRP, WMS and CBR rates were set by the OEB on December 16, 2021.²¹

The Smart Metering Entity Charge is a component of the "Distribution Charge" on a customer's bill, established by the OEB through a separate order. The Smart Metering Entity Charge was set by the OEB on March 1, 2018.²²

In the *Report of the Board: Review of Electricity Distribution Cost Allocation Policy*,²³ the OEB indicated that it will review the default province-wide microFIT charge annually to ensure it continues to reflect actual costs in accordance with the established methodology. On January 26, 2022, the OEB issued a letter advising electricity distributors that the microFIT charge shall remain at \$4.55 for the duration of the 2022 calendar year.

RESIDENTIAL SERVICE CLASSIFICATION

This classification refers to the supply of electrical energy to customers residing in residential dwelling units. Energy is generally supplied as single phase, 3-wire, 60-Hertz, having nominal voltage of 120/240 Volts and up to 400 amps. There shall be only one delivery point to a dwelling. The Basic Connection for Residential consumers is defined as 100 amp 120/240 volt overhead service. A Residential building is supplied at one service voltage per land parcel. Class B consumers are defined in accordance with O. Reg. 429/04. Further servicing details are available in the distributor's Conditions of Service.

APPLICATION
