In response to the OEB Decision and Rate Order on March 24, 2022, Enbridge would like to outline the measures taken to address customer communications.

Utilizing our array of communication channels and tools, on April 1, 2022, Enbridge is going to publish the following customer message on Enbridge's website, in the natural gas rates section of the site, within the introduction to the frequently asked questions.

"North American natural gas prices have increased from last year's historic lows for a number of reasons - colder than normal weather, COVID uncertainty and conflict in Europe, among others. We understand that energy affordability is a priority for Ontario families and businesses. Since October 2021, we've taken steps, with the OEB's approval, to "smooth out" the actual increase in natural gas prices to lower the total bill for customers over time. The "smoothed out" costs will be recovered gradually over the coming months to help customers manage their energy bills."

The main banner on the website will provide a link to this communication and our social media posts will point to this information on enbridgegas.com/gas-rates-notice.

The need to "smooth out" increases in natural gas prices will be reassessed on a quarterly basis and customer communications will be revised accordingly.

With regards to customer rate notices, Enbridge intends to address the comments received and improve clarity to the wording in the applicable notices for the July 2022 QRAM.

In addition, please find the attached listing of all parties who will be served notice in the July 2022, QRAM application. Going forward, Enbridge will include this listing within the application.
