GAPLO/LCSA/CAEPLA - Notice of Intent to Request an Award of Costs

I am writing on behalf of the Gas Pipeline Landowners of Ontario ("GAPLO"), the Lambton County Storage Association ("LCSA") and the Canadian Association of Energy and Pipeline Landowner Associations ("CAEPLA"). GAPLO and LCSA are voluntary organizations of landowners directly affected by Enbridge Gas Inc. projects and facilities within the Board's jurisdiction. CAEPLA is Canada's leading national grassroots property rights organization and represents energy and pipeline landowners across Canada, including landowners directly affected by Enbridge Gas Inc. projects and facilities within the Board's jurisdiction. GAPLO, LCSA and CAEPLA intend to provide comments jointly to the Board in the current consultation process and hereby notify the Board of their intention to request an award of costs.

With reference to the Board's cost eligibility criteria set out in Section 3 of the Practice Direction on Cost Awards, it is submitted that GAPLO, LCSA and CAEPLA represent both a public interest and a policy perspective relevant to the Board's mandate and to this particular consultation process. Landowners facing applications by companies for the construction and operation of Board-regulated projects on their properties rely on the Board's intervenor processes and costs awards to enable their full and fair participation in the approvals processes. The landowner perspective on intervenor processes and cost awards is an important one.

GAPLO and LCSA are voluntary organizations funded entirely through contributions by their landowner members. CAEPLA is a not-for-profit corporation funded through member contributions and through any funding obtained in connection with CAEPLA's representation of landowner in energy project applications. None of GAPLO, LCSA and CAEPLA has any other funding available for the Board's current consultation process.

GAPLO, LCSA and CAEPLA intend to retain me to submit comments on their behalf in the consultation process. I was called to the Bar of Ontario in 2005 and since that time have represented landowner organizations and individual landowners in several proceedings before the Board, including policy consultations and leave to construct and expropriation hearing processes. A copy of my curriculum vitae is enclosed.
