Hydro One filed an application with the Ontario Energy Board (OEB) on February 24, 2022, under section 78 of the *Ontario Energy Board Act, 1998*, for an Accounting Order to establish a sub-account pertaining to the deferral of capital contributions payable to Hydro One by Toronto Hydro-Electric System Limited.

A Notice of Hearing and Procedural Order No. 1 (Notice and PO1) was issued on March 24, 2022. Each of SEC and PWU applied for intervenor status. SEC also applied for cost eligibility.

No objection was received from Hydro One.

SEC and PWU are approved as intervenors. SEC is eligible to apply for an award of costs under the OEB's <u>Practice Direction on Cost Awards</u>. The list of parties in this proceeding is attached as Schedule A to this letter.

SEC and PWU should review the OEB's Notice and PO 1 for the schedule for the case and if they will be filing interrogatories should consult sections 26 and 27 of the OEB's Rules of Practice and Procedure regarding required naming and numbering conventions related to interrogatories.
