Applications for Electricity Generation Licence Amendments

DECISION AND ORDER

On December 10, 2021, applications were filed by Northland Power Inc. (NPI), Kingston Cogen Limited Partnership (KCLP) and Iroquois Falls Power Corp. (IFPC) with the Ontario Energy Board (OEB) for amendments to their respective electricity generation licences.

Through their applications, NPI, KCLP and IFPC (the applicants) seek to amend Schedule 1 of their respective electricity generation licences. Schedule 1 of a generation licence lists the licensee's generation facilities and the ownership and/or operational authorizations granted by the OEB with respect to those facilities. Specifically, the applicants have asked the OEB to amend their licences as follows:

1. Delete the following authorizations from the NPI licence EG-2003-0103:

“The operation of Iroquois Falls Power Corp. gas fired generating station, with an installed capacity of 120MW, located at 1 Industrial Road, Iroquois Falls, Ontario”; and,

“The operation of Kingston CoGen generation facility, with an installed capacity of 110 MW located at 5146 Taylor Kidd Blvd., Bath, Ontario”.

2. Amend the KCLP licence EG-2003-0137 to include the authorization to operate as a generator, by adding the underlined words:

The ownership and operation of Kingston CoGen generation facility, with an installed capacity of 110 MW located at 5146 Taylor Kidd Blvd., Bath, Ontario.

3. Amend the IFPC licence EG-2003-0144 to add the authorization to operate as a generator, by adding the underlined words:

The ownership and operation of Iroquois Falls Power Corp. gas fired generating station, with an installed capacity of 120MW, located at 1 Industrial Road, Iroquois Falls, Ontario.

The applications were filed in relation to a commercial transaction that would result in the operational control of the Kingston Cogen Limited Partnership Generating Station and the Iroquois Falls Power Corp. Generation Station being transferred from NPI to KGLP and IFPC, respectively. Given the interrelated nature of the transaction, the OEB combined the applications into one proceeding, pursuant to section 21(5) of the OEB Act. This Decision

and Order is being issued by the Delegated Authority without a hearing pursuant to section 6(4) of the OEB Act.

On April 8, 2022 the applicants filed a letter stating that the transaction had been completed on April 7, 2022.

The OEB finds that the applications should be granted. There are no amendments beyond the changes to Schedule 1 for any of the applicants.

IT IS ORDERED THAT:

1. Northland Power Inc.'s application to amend Schedule 1 of its electricity generation licence EG-2003-0103 is granted. A copy of the licence, as amended, is attached to this Decision and Order.
2. Kingston Cogen Limited Partnership's application to amend Schedule 1 of its electricity generation licence EG-2003-0137 is granted. A copy of the licence, as amended, is attached to this Decision and Order.
3. Iroquois Falls Power Corp.'s application to amend Schedule 1 of its electricity generation licence EG-2003-0144 is granted. A copy of the licence, as amended, is attached to this Decision and Order.
