As you know, the Ontario Energy Board (“**OEB**”) is convening a Reliability and Power Quality Review Working Group (“**Working Group**”) as part of its Reliability and Power Quality Review under OEB No.: EB-2021-0307 (“**RPQR**”). The OEB has asked stakeholders to submit nominees for the Working Group by April 15, 2022.

  - Marvio has also been a leader in preparing certain Reporting and Record Keeping Requirements (RRRs) for ENWIN and, more recently, he has gained experience with the OEB’s Activity and Program-based Benchmarking Initiative. Marvio was also an active contributor to ENWIN’s 2020 Cost of

Service rate application (EB-2019-0032).

- In addition to being an electrical engineer with a P.Eng. designation in Ontario, Marvio earned a Masters of Science in Electrical Power Systems Engineering focused on knowledge-based online security assessment from the University of Manchester Institute of Science and Technology, and he earned a Masters Certificate in Energy Sector Leadership from the York University Schulich School of Business.

ENWIN believes that Marvio would be an asset for the Working Group with his extensive experience addressing technical issues and challenges, including relating to reliability and power quality, as well as his knowledge of the OEB's RRRs and APB Initiative. In addition, Marvio can provide the unique perspective of a mid-sized electricity distributor to the Working Group.
