Re: EB-2021-0307 Reliability and Power Quality Review – Working Group Nomination

On March 31, 2022, the Ontario Energy Board ("OEB") issued a letter setting out the OEB's plan for the Reliability and Power Quality Review ("RPQR"). The letter stated a RPQR Working Group ("RPQR WG") will be established to provide input on technical issues and challenges, as well as assist OEB staff in the development and implementation of benchmarking, customer-specific reliability and reliability analytics. The letter invited stakeholders that wish to participate in the RPQR WG to indicate their interest by letter addressed to the Registrar.
