## Re: *Request for an Amendment to Electricity Wholesaler Licence to Reflect Name Change* Licencee: Exelon Generation Company, LLC

Constellation Energy Generation, LLC ("Constellation") requests that the Ontario Energy Board ("OEB") amend Electricity Wholesaler Licence No. EW-2021-0213, issued to Exelon Generation Company, LLC on October 28, 2021, to reflect a corporate name change. On February 1, 2022, Exelon Generation Company, LLC's name was changed to Constellation Energy Generation, LLC, as evidenced by the attached Pennsylvania Department of State Certificate of Amendment. Additionally, a copy of the Ontario Company Name Registration is attached. This name change occurred in connection with Exelon Corporation's separation of its traditional utility business from its generation business (Constellation), which is now an independent company. Although Constellation's name has changed, the legal entity remains the same and as such no new licence or transfer of the licence is required. Constellation respectfully requests that the OEB act on this requested amendment as soon as possible.

Constellation requests, and consents to, the OEB disposing of the proceeding without a hearing pursuant to section 21(4)(b) of the *Ontario Energy Board Act, 1998*. Constellation also confirms that no other person will be adversely affected in a material way by the outcome of the proceeding.

There are no changes to the licensee's address or the contact name for the licensee.

Pursuant to OEB guidance regarding name change amendments, in addition to the name change documentation described above, we are providing updated information on Key Individuals and organizational charts. Constellation respectfully requests that the attached information pertaining to Key Individuals and Constellation's organizational structure be treated as confidential, consistent with how such information has previously been treated by OEB.

## *Key Individual Updates*

The Application submitted in September 2021 to renew the license listed Jason Miller, David Dardis and Bryan Wright as Key Individuals of the licensee. David Dardis remains a key individual in his current position as Executive Vice President and General Counsel. Constellation wishes to supplement its Key Individual information with information of Daniel Eggers, Executive Vice President and Chief Financial Officer of Constellation, and Vivek Charmria, Senior Vice President of Power Trading & UK for Constellation. Mr. Eggers and Mr. Chamria now hold similar roles to those previously held by Bryan Wright and Jason Miller, who were identified as Key Individuals in the September 2021 renewal. Key Individual information for both Mr. Eggers and Mr. Charmria are attached.

## Organizational Charts

The corporate organizational charts for before and after the name change and associated restructuring are attached.

As noted above, Constellation respectfully requests that the attachments relating to Constellation's Key Individuals and its organizational structure be treated as confidential, consistent with how such information has been treated in prior submissions to OEB.
