Re: EB-2022-0071 - Hydro One Motion to Review - SEC Cost Claim

We are counsel to the School Energy Coalition ("SEC"). Enclosed, please find SEC's cost claim in this matter on the OEB's form with accompanying detailed dockets.

This was a motion by Hydro One to review certain parts of the OEB's decision in EB-2021-0033 relating to accounts 1576 and 1592. Because it was a motion, almost all of the time was spent on researching and then preparing submissions on that motion. Senior counsel Jay Shepherd took the lead, and drafted the submissions. Counsel Mark Rubenstein's role focused on supervising junior counsel Fred Zheng in legal research related to the case. More work than normal was necessary on this because Hydro One put forward some unique arguments relating to retroactive ratemaking and the "benefits follow costs" principle. Also, the policy history on which the motion centred was not completely straightforward, and that had to be addressed.
