Re: EB-2020-0293 – Enbridge St. Laurent LTC – SEC Cost Claim

We are counsel to the School Energy Coalition ("SEC"). Enclosed please find SEC's cost claim in this matter on the OEB's form with accompanying detailed dockets.

This was an application for leave to construct the third and fourth phases of the St. Laurent Replacement Pipeline serving much of downtown Ottawa, as well as Gatineau. In addition to the normal evidence from the Applicant, SEC co-sponsored evidence with the City of Ottawa and Pollution Probe on plans by many customers to eventually eliminate gas use in Ottawa. Enbridge also filed Reply Evidence. There were two rounds of interrogatories on Enbridge evidence, and one on the Sponsors' evidence, plus a two-day Technical Conference and undertakings flowing from it. There was also a procedural challenge by another party relating to the conduct of the Technical Conference.

Management of the witnesses, including their written evidence, responses to interrogatories, participation in the technical conference (including witness prep), and responses to undertakings, was assigned to junior counsel Fred Zheng, under the supervision of senior counsel Jay Shepherd. Mr. Zheng also did the initial evidence review and drafting of interrogatories, and provided support on final argument. Mr. Shepherd took primary responsibility for collaboration with the other Sponsors, client input and reporting, and attendance at the technical conference. He also drafted the final argument, and had carriage of the overall matter throughout.

SEC has reviewed the time spent by Mr. Zheng, who was responsible for the witnesses, the most time-intensive aspects of the case, and has reduced the claim by 20 hours for learning

time. In SEC's view, the balance of his hours were productive and of value to the process and the OEB.

Co-counsel Mark Rubenstein had a limited role in reviewing technical issues.

Time spent co-ordinating with the other Sponsors on the intervenor evidence has been allocated to the category "Communication with Other Parties". Time spent on the procedural issue has been included in "Technical Conference – Followup", along with the undertakings from the Technical Conference. Time spent under "Review Application and Evidence" and "Preparation of Interrogatories" includes the initial evidence, evidence updates, and reply.
