Re: Notice of Hearing for Cost Awards Regional Planning Process Review Ontario Energy Board File No. EB-2020-0176

This notice invites eligible participants in the Regional Planning Process Review (RPPR) consultation to submit cost claims for eligible activities that took place between February 15, 2021 and May 15, 2022.

Background

On December 10, 2020, the Ontario Energy Board (OEB) issued a <u>letter</u> (December 2020 letter) that initiated a consultation to undertake a review of the regional planning process that applies to Ontario's electricity sector. The December 2020 letter indicated that the first step in the RPPR consultation involved re-establishing the Regional Planning Process Advisory Group (RPPAG) to assist the OEB in that review. On December 20, 2021, the RPPAG completed the first phase of its work in providing its Report to the OEB with recommendations for the OEB's consideration. The OEB then issued a <u>letter</u> (April 2022 letter) with its response to those recommendations and an implementation plan on April 28, 2022.

The December 2020 letter indicated that cost awards will be available, under section 30 of the *Ontario Energy Board Act, 1998* (Act), to eligible participants in relation to the RPPAG activity described in that letter and would continue to be available for any activities that may be necessary following the completion of the RPPAG's work during the first phase of this consultation process. The letter also advised that cost awards will be available to eligible participants for participation in meetings of the RPPAG, to a maximum of actual meeting time plus 50% of meeting time for preparation and reporting.

The December 2020 letter further indicated that costs awarded will be recovered from all rate-regulated licensed electricity distributors (65% of the costs awarded) and all rate-regulated licensed transmitters (35% of the costs awarded). Within the distributor class, costs awarded will be apportioned based on respective customer numbers. Within the transmitter class, apportionment will be based on respective revenues (using the most recent three-year average from their audited financial statements or similar documentation).

On January 18, 2021, the OEB issued its <u>decision</u> on cost eligibility. The OEB determined the following organizations would be eligible for an award of costs in relation to cost eligible activities (collectively, the eligible participants):

- Common Voice Northwest
- Pollution Probe
- School Energy Coalition

Eligible Activities

The cost eligible RPPAG activities undertaken between February 15, 2021 and May 15, 2022 are summarized below with additional details provided in Appendix A to this Notice:

- Preparation for, attendance at, and reporting on RPPAG meetings up to 1.5 times actual attended meeting time.
- Preparation for, attendance at, and reporting on Load Forecast Guideline subgroup meetings up to 1.5 times actual attended meeting time.
- Preparation of the RPPAG Report to the OEB with recommendations to improve the regional planning process. In addition, preparation of the Load Forecast Guideline by members of the subgroup.

In relation to preparing the RPPAG Report to the OEB, two approaches were considered: (1) additional meetings to discuss feedback on draft versions; or (2) provide feedback in writing via e-mail (and a meeting, if necessary). The latter was determined to be more efficient and facilitate a greater focus on important details. In order to address this change in approach and ensure that eligible parties were able to fully participate, the OEB will provide a maximum of 13.5 hours for eligible parties' participation in the review and commenting on the draft Report. This amount of time is

equivalent to two meetings of the RPPAG and, in the OEB's view, that is representative of the time involved in reviewing and commenting on the draft Report.¹

The OEB will apply the same approach to the development of the Load Forecast Guideline. It is a much a briefer document and involved much less debate, as it was focused on addressing on a single issue that is technical in nature. The OEB expects it would have required two subgroup meetings for review and feedback. Cost awards will therefore be available to eligible participants for reviewing and commenting on that document to a maximum of 4.5 hours.²

As noted above, cost awards will continue to be available to eligible participants in relation any activities that are necessary following the completion of the RPPAG's work that culminated in the Report to the OEB with its recommendations. As discussed in the April 2022 letter, that will include the RPPAG's work related to implementing the recommendations that require RPPAG action. The Implementation Plan attached to that letter also identified proposed changes to OEB regulatory instruments (e.g., feedback on proposed Code amendments). The OEB will provide further direction regarding cost claims for the period after May 15, 2022, at the appropriate time.

Notice of Hearing

The OEB is initiating a hearing on its own motion to determine the cost awards that will be made in accordance with section 30 of the Act, for the period between February 15, 2021 and May 15, 2022. The decision on costs awarded will be made by a delegated authority under section 6 of the Act. The hearing will follow the process set out below.

- Eligible participants intending to claim cost awards shall submit their cost claims by July 11, 2022. The cost claim must be filed with the OEB and must be completed in accordance with section 10 of the OEB's <u>Practice Direction on Cost</u> <u>Awards</u>. Any cost claims will be available for review by rate-regulated licensed electricity distributors and transmitters through the OEB's website under file number EB-2020-0176.
- Rate-regulated licensed electricity distributors and transmitters will have until July 18, 2022 to object to any aspect of the costs claimed. The objection must be filed with the OEB, and one copy must be served on the eligible participant against whose claim the objection is being made.

¹ RPPAG meetings throughout the process were from 9:30 am to 3:00 pm with a one-hour break for lunch (i.e., 4.5 hours of actual meeting time + 50% = 6.75 hours per meeting).

 $^{^{2}}$ Except for the final meeting, all Load Forecast subgroup meetings throughout the process were 1.5 hours (i.e., 1.5 hours of actual meeting time + 50% = 2.25 hours per meeting).

- 3. The participant whose cost claim was objected to will have until **July 25, 2022** to file a reply submission with the OEB as to why its cost claim should be allowed. One copy of the reply submission is to be served on the objecting party.
- 4. The OEB will then issue its decision on cost awards. The OEB's costs will also be addressed in the cost awards decision.

The OEB will use the process set out in section 12 of its *Practice Direction on Cost Awards* to implement the payment of the cost awards. The OEB will therefore act as a clearing house for all payments of cost awards in this process.

How to File Materials

Stakeholders are responsible for ensuring that any documents they file with the OEB **do not include personal information** (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's <u>Rules of Practice and Procedure</u>.

- Cost claims are now filed through the OEB's online filing portal. Please visit the <u>File documents online page</u> of the OEB's website for more information. You will find "Cost Claim filings" under "Filing Systems".
- All eligible participants shall download a copy of their submitted cost claim and serve it on all required parties as per the <u>Practice Direction on Cost Awards</u>.
- Cost claim filings should clearly state the sender's name, postal address, telephone number and e-mail address.
- Please use the document naming conventions and document submission standards outlined in the <u>Regulatory Electronic Submission System (RESS)</u> <u>Document Guidelines</u>.
- Parties are encouraged to use RESS. Those who have not yet <u>set up an</u> <u>account</u>, or require assistance using the online filing portal can contact <u>registrar@oeb.ca</u> for assistance.
