#### Re: EB-2021-0056 - Rideau St. Lawrence 2022 - Cost Claim

We are counsel to the School Energy Coalition ("SEC"). Attached, please find the cost claim using the OEB's cost claim system.

SEC junior counsel, Fred Zheng, had carriage of this matter, with the undersigned providing general assistance and supervision, as well as having specific responsibility for certain discrete technical issues (ICM true-up, ACM, accounting matters, PILs, deferral and variance accounts). This arrangement allowed for a more cost-effective participation in this proceeding.

For the purpose of cost claim categorization, where dockets include both reviewing evidence and preparing interrogatories, or reviewing interrogatory responses and preparing for the settlement conference, we have allocated 50% to each specific category activity. As a practical matter, each set of activities are done at the same time and so cannot be readily extricable (e.g. we are preparing IRs as we review the evidence).
