**Re: EB-2022-0003 – Enbridge Waterfront Relocation #2 – SEC Cost Claim**

We are counsel to the School Energy Coalition (“SEC”). Enclosed, please find SEC’s cost claim in this matter on the Board’s form with accompanying detailed dockets.

This proceeding was the followon from EB-2020-0198, which was withdrawn, and represents a variation on the original plan at a much lower cost. SEC was an intervenor in that prior application.

Junior counsel Fred Zheng had the lead on this matter, with active assistance from Senior Counsel Jay Shepherd, particularly with respect to the identification of key concerns and the finalization of the SEC submissions. As part of our reasonableness review for this cost claim, and in light of Mr. Shepherd’s active involvement, SEC decided to cap the time claimed for Mr. Zheng at 10 hours for the review of the application materials, 10 hours combined for the preparation of interrogatories and review of responses, and 5 hours for written submissions. The rest has been treated as learning time. Additional time spend by Mr. Rubenstein has also not been claimed.
