- I. SR LP, SR II LP, SR GP, SLGR and HONI have entered into an Assignment and Assumption Agreement and Connection Agreement Amending Agreement with respect to the Snowy Ridge wind power project (the “**Snowy Ridge HONI Assignment**”).
