**Re: EB-2022-0079 Non-RPP Class B Pilot Program**

Pursuant to your letter of invitation to interested parties dated July 13, 2022 regarding the above-noted matter, the Quinte Manufacturers Association ("QMA" or "Association") would be pleased to participate in the virtual stakeholder meeting scheduled for July 28, 2022 and to submit comments and provide appropriate feedback to the OEB by August 25, 2022.
