Leave to Construct Application – Chatham by Lakeshore

We are counsel to the Chippewas of Kettle and Stony Point First Nation together with Southwind Corporate Development Inc. ("CKSPFN") in the above-noted proceeding (the "Proceeding"). CKSPFN wishes to advise the Board that Caldwell First Nation ("Caldwell") has joined with CKSPFN for the purposes of this Proceeding. CKSPFN consequently requests that its intervenor status and cost eligibility in the Proceeding be continued under the name of Three Fires Group Inc. ("TFG"), on behalf of both CKSPFN and Caldwell. TFG accepts the record of the Proceeding as it stands and intends to participate fully in the balance of the Proceeding (including filing interrogatories in accordance with Procedural Order No. 1).

Caldwell's traditional territory includes lands and waters in Southern Ontario from the Detroit River along the north shore of Lake Erie to Long Point, including Point Pelee and Pelee Island. Caldwell's traditional territory, and associated rights and interests protected by the *Constitution Act, 1982*, may be impacted by the outcomes of this Proceeding and the application in this Proceeding may affect Caldwell's treaty rights, land and water use, and cultural heritage. The Ministry of Energy, Northern Development and Mines delegated the procedural aspects of the duty to consult CKSPFN and Caldwell on the application to Hydro One on November 29, 2019.

TFG is an Indigenous business corporation that was incorporated on July 19, 2022, and jointly represents the interests of CKSPFN and Caldwell. TFG is, in accordance with sections 3.03(a) and (b) of the Board's *Practice Direction on Cost Awards*, eligible to seek an award of costs as a party that primarily represents the direct interests of Indigenous consumers in relation to services that are regulated by the Board and a unique interest or policy perspective that is relevant to the Board's mandate and to the Proceeding.

We request that the following additional representatives of TFG be added to the list of intervenors in this Proceeding:
