Re: Milton Hydro Distribution Inc. ("Milton Hydro") EB-2022-0049: Cost of Service Rate Application for 2023 Electricity Distribution Rates ("Application") – Request for Confirmation of Non-Relevance

We are counsel to Milton Hydro, the applicant in the above-referenced proceeding. Milton Hydro filed its responses to interrogatories on July 25, 2022. Pursuant to the OEB's *Practice Direction on Confidential Filings* (the "Practice Direction"), Milton Hydro hereby requests the OEB to confirm that certain information contained in interrogatory response, 1-SEC-014 is not relevant to the proceeding and, as a result, should be permanently redacted.

Certain portions of the Business Plan and Budget documents, which are included as Attachments 1-1 to 1-3 to interrogatory response, 1-SEC-004, part (a) contain financial and other information that relates to Milton Hydro's non-rate regulated affiliates and their non-rate regulated business. This information is not relevant and would not assist the OEB in deciding the matters at issue in this application. Milton Hydro has therefore redacted the non-relevant portions of the documents and access will be provided to the OEB only in accordance with section 11 of the Practice Direction.
