We are counsel to Anwaatin Inc. ("**Anwaatin**") in the above-noted consultation (the "**Consultation**"). Further to the Board's Notice of Hearing for Cost Awards dated August 10, 2022, please find enclosed Anwaatin's cost claim in respect of the Consultation.

Anwaatin respectfully requests an award of 100% of its eligible costs, given its strategic and principled participation in the Consultation, reflecting the unique interests of Anwaatin's First Nation members. Anwaatin submits that this request is supported by the following considerations:

- (i) Anwaatin participated effectively, taking a surgical, principled, and coordinated approach to the issues and undertaking coordination with other participants to avoid overlap and maximize efficiency in all aspects of the Consultation;
- (ii) Anwaatin participated responsibly and made reasonable efforts to ensure that its participation was not unduly repetitive and was focused on relevant and material issues; and
- (iii) Anwaatin contributed to the Board's better understanding of issues in the Consultation by filing written comments.

We trust that this approach maximizes efficient use of resources and the right of otherwise unrepresented and important First Nations to be heard in a manner that is consistent with the Board's mandate and statutory objectives.

Anwaatin respectfully requests a full award of eligible costs.
