Further to the evidence filed by CAEPLA-DCLC on August 12, 2022 in the above noted proceeding, and consistent with the OEB’s Procedural Order No. 4 dated July 26, 2022, this is the Reply Evidence of Enbridge Gas.

While Enbridge Gas is eager to continue discussions with CAEPLA-DCLC to resolve all outstanding matters, CAEPLA-DCLC representatives have not engaged in meaningful negotiations with the Company since it presented its form of Letter of Understanding (“LOU”) to CAEPLA-DCLC in late June. Enbridge Gas believes that it is in the best interest of all parties to resume negotiations immediately and to reach agreement on the outstanding matters outside of the formal OEB hearing for Leave to Construct (“LTC”) the proposed Project.


For these reasons, Enbridge Gas hereby requests that the OEB order that, and make provision for, formal settlement negotiations to occur between Enbridge Gas and CAEPLA-DCLC outside of and in parallel with the current LTC proceedings so as to avoid causing further procedural delay that might impact the timing of a Decision and Order from the OEB on the Company’s LTC Application or the commencement of Project construction.
