#### **Archaeological Resources**

The Stage 1 Archaeological Assessment (AA) is expected to be submitted to the MHSTCI this week (Feb 28. – Mar. 4). The Environmental Report will be updated to include the detailed recommendations that are noted in the draft Stage 1 AA (e.g. recommendation regarding Stage 3 Cemetery Investigations due to the project's close proximity to the Glenwood Cemetery.

#### **Built Heritage Resources and Cultural Heritage Landscapes**

The MHSTCI Criteria for Evaluating Potential for Built Heritage Resources and Cultural Heritage Landscapes checklist was prepared for the IOL Pipeline Relocation Project. ### Good day,

MHSTCI has reviewed the Environmental Report for this project as part of the Ontario Pipeline Coordinating Committee. Our interest in this project relates to the conservation of cultural heritage resources (archaeological resources, built heritage resources and cultural heritage landscapes). We provided preliminary advice and comments on July 28, 2021 (attached here).

Overall, the Environmental Report needs to provide more information to support its findings about impacts to cultural heritage resources.

#### **Archaeological Resources**

Our comments from July 2021 advise that, at a minimum, a Stage 1 archaeological assessment should be prepared during the project planning phase, and the findings incorporated into the Environmental Report. Section 3.4.8 Archaeological Resources of the Environmental Report states that a Stage 1 archaeological assessment was prepared for the project. Our records show that the report has not yet been submitted to the ministry by the licensed archaeologist for review. It is only once the report has been screened or reviewed by MHSTCI and entered onto the Ontario Public Register of Archaeological Reports that it can be considered finalized. At this point in time, this component of the project reporting is incomplete.

We also note that the draft archaeological assessment makes more detailed recommendations than are presented in the body of the Environmental Report (e.g. recommendation regarding Stage 3 Cemetery Investigations due to the project's close proximity to the Glenwood Cemetery). It is our standard advice that the recommendations within the Executive Summary of the archaeological assessment, containing project specific details and recommendations, are incorporated into the body of the Environmental Report.

### **Built Heritage Resources and Cultural Heritage Landscapes**

Section 3.4.9 Cultural Heritage Resources identifies cultural heritage resources within the study area, but states that the Cultural Heritage Report: Existing Conditions and Preliminary Impact Assessment will be completed prior to construction. MHSTCI recommends that the Cultural Heritage Report is prepared now, so that it can inform the Environmental Report and make preliminary recommendations for the conservation of known and potential cultural heritage resources.

These are all of our comments on the Environmental Report. Thank you for the opportunity to review and comment on the document.



Good afternoon Joan, thank you for the comments on the ER.

We will let IOL know that for any potential blasting activities to try and coordinate with LaFarge since as you say, Lafarge would likely receive any complaints associated with blasting in this area.

The project team understands it is the responsibility of the IOL to ensure SAR are not killed, harmed or harassed and that their habitat is not damaged or destroyed through the proposed activities to be carried out on the site. As noted in the ER, if SAR are encountered during the proposed pipeline replacement, all work will stop and consultation with the MECP regarding the potential need for a permit under the ESA and/or species specific mitigation will be conducted.

Lastly, our hydrogeological team have reviewed the groundwater levels in existing borehole records along the preferred route that along with the knowledge that Lafarge has drawn down the groundwater table in the study area to complete their extraction activities has helped us determine that a PTTW will not be required for this project.

Thank you for the clarification. We reviewed the report and offer the following comments:

- The Environmental Report mentions having to do possible blasting, and notes that landowners
  will be notified and existing conditions will be documented. It should also be noted that Lafarge
  blasts regularly in the north quarry (directly north of the proposed pipeline relocation), so
  coordination with Lafarge would be beneficial, as Lafarge would likely receive any complaints
  associated with blasting in this area.
- Source Protection Programs Branch (SPPB) notes that their previous comments on this project have been addressed in the Environmental Report.
- Please note that it is the responsibility of the proponent to ensure that Species at Risk (SAR) are not killed, harmed, or harassed, and that their habitat is not damaged or destroyed through the proposed activities to be carried out on the site. If the proposed activities cannot avoid impacting protected species and their habitats, then the proponent will need to apply for an authorization under the Endangered Species Act (ESA). As noted in the report, If the proponent believes that their proposed activities are going to have an impact or are uncertain about the impacts, they should contact <a href="mailto:SAROntario@ontario.ca">SAROntario@ontario.ca</a> to undergo a formal review under the ESA.
- It is recommended that the proponent consult with the PTTW Unit of the Environmental Permissions Branch of the Ministry of the Environment, Conservation and Parks to determine any Permit to Take Water (PTTW) or Environmental Activity and Sector Registry (ESAR) requirements (enviropermissions@ontario.ca).


