Re: Joint Letter on Status of Settlement Negotiations Enbridge Gas Inc. Dawn to Corunna Replacement Project Ontario Energy Board File Number: EB-2022-0086

This letter responds to the Canadian Association of Energy and Pipeline Landowner Associations and its subcommittee the Dawn Corunna Landowner Committee (CAEPLA-DCLC) letter dated August 24, 2022. In response to the CEAPLA-DCLC letter, the Ontario Energy Board will extend the due date for a joint letter from CAEPLA-DCLC and Enbridge Gas Inc. regarding the status of their settlement negotiations to September 15, 2022.

On August 23, 2022, the OEB issued a letter that, in part, stated the OEB would not order formal settlement negotiations between CAEPLA-DCLC and Enbridge Gas because negotiations appear to be progressing and both parties have an interest in reaching agreement as soon as possible. The OEB directed that, to avoid delay in issuing its Decision and Order in this proceeding, a joint letter from the parties must be filed no later than the due date for Enbridge Gas's Argument-in-Chief advising whether any outstanding issues have been settled and describing any agreement. The joint letter would identify any outstanding issues that have not been settled, if applicable. The parties were directed to address those issues in their written submissions as currently provided for in Procedural Order No. 4.

On August 23, 2022, CAEPLA-DCLC filed a letter to inform the OEB that a negotiation meeting between CAEPLA-DCLC and Enbridge Gas has been scheduled for September 9, 2022. Given the timing of this meeting, CAEPLA-DCLC stated that it

would not be possible to provide a joint letter before the due date for Enbridge Gas's Argument-in-Chief, which is September 6, 2022.

The OEB will extend the due date for a joint letter from CAEPLA-DCLC and Enbridge Gas to September 15, 2022. The joint letter will advise whether any outstanding issues have been settled and describe any agreement. The joint letter should also describe any outstanding issues that have not been settled. CAEPLA-DCLC will addressed any agreement and any outstanding issues in its written submissions, as may any interested intervenor, and Enbridge will respond in its reply argument, on the schedule currently provided for in Procedural Order No. 4.
