- 3) If Enersource Hydro Mississauga Inc. is a host distributor, to immediately, and no later than the date of publication of the Notice, serve a copy of the Notice directly on any embedded distributor(s).
- 4) To serve a copy of the Notice directly on each party of record in the combined smart meter proceeding (proceeding EB-2007-0063) and each party of record in the proceeding held to determined Enersource Hydro Mississauga Inc.'s 2008 electricity distribution rates (proceeding EB-2007-0706).
- To file with the Board an affidavit proving the above publication and service of the Notice immediately upon completion, with the Notice and original post office registration receipts or courier confirmation lists attached as appendices. It is not necessary for the affidavits of publication to have newspaper tear sheets attached.
- 6) To immediately make a copy of the application, the pre-filed evidence and any additional materials as they are developed, available for public review at Enersource Hydro Mississauga Inc.'s office and on its website.
